**MINERAL COUNTY REPORT**

1 Mineral County hereby submits the following information related to its service efforts on  
2 the final list of 107 Proposed Defendants to be served via Fed. R. Civ. P. Rule 4 service, which  
3 the Court approved in its August 2, 2012, Order Relating to Completion of Service. Doc. No.  
4 605.<sup>1</sup> This Report sets forth the status of service on each of these 107 Proposed Defendants. In  
5 August and September of 2012, Mineral County mailed copies of the approved service package  
6 and request for waiver to each of the Proposed Defendants who remain to be served via certified  
7 mail. *See* Exhibits A-1 through A-107. In response to that mailing, Mineral County received  
8 signed waivers of personal service forms from approximately one third of these Proposed  
9 Defendants. Mineral County has attempted to personally serve all of the remaining Proposed
