By order dated June 13, 2000, the Magistrate ordered the parties to submit “[s]imultaneous briefs as to the position of the parties . . . by July 26, 2000, with courtesy copies sent to chambers.” *Minutes of the Court* at 2 (June 13, 2000). Those briefs must address whether the parties have reached agreement on several documents for service of the first amended counterclaims of the Walker River Paiute Tribe (“Tribe”) and the United States pursuant to the terms of the *Case Management Order* (Apr. 19, 2000). The documents are: 1) notice of lawsuit and request for waiver of service; 2) notice in lieu of summons; and 3) lis pendens or other form of constructive notice of the lawsuit. The Magistrate scheduled a status conference on July 31, 2000 to discuss the parties’ positions regarding these documents. Subsequently, by order dated June 26, 2000, the Magistrate rescheduled the status conference for September 5, 2000. *Minutes of the Court* (June 26, 2000). However, the Magistrate did not alter the date for submission of briefs by the parties.

The parties wish to continue their discussions regarding the documents listed above during the month of August. Accordingly, the parties hereby stipulate and agree that the date for submission of briefs by the parties setting forth their respective positions on the documents listed above and any related issues shall be ~~September 1~~, 2000. The parties respectfully request that the Magistrate enter an order extending the time for filing briefs setting forth the parties’ positions on procedures for service of


