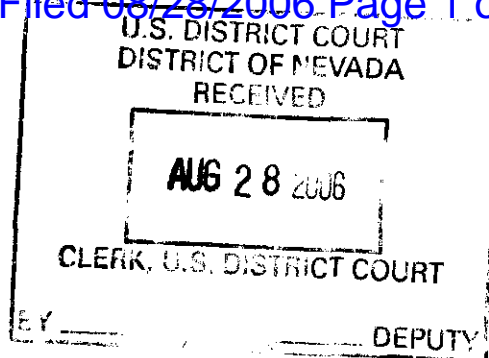

ORDER

Plaintiff, who is in the custody of the Nevada Department of Corrections, has submitted an application to proceed *in forma pauperis* (#1) seeking to initiate a civil rights action pursuant to 42 U.S.C. § 1983. The Court finds that plaintiff must pay an initial partial filing fee of \$33.33 toward the full filing fee of three hundred fifty dollars (\$350.00), pursuant to 28 U.S.C. § 1915(b)(1). Accordingly,

IT IS ORDERED that plaintiff's application to proceed *in forma pauperis* is GRANTED; however, plaintiff shall be required to pay an initial installment fee in the amount of \$33.33 toward the full filing fee of three hundred fifty dollars (\$350.00). Plaintiff shall have thirty (30) days from the date this order is entered in which to have the designated fee sent to the Clerk of Court. Failure to do so may result in dismissal of this action. Furthermore, even if this action is dismissed, the full filing fee still must be paid pursuant to 28 U.S.C. § 1915(b)(2).

1 IT FURTHER IS ORDERED that the movant herein is permitted to maintain this action  
2 to conclusion without the necessity of prepayment of any additional fees or costs or the giving  
3 of security therefor. This order granting *forma pauperis* status shall not extend to the  
4 issuance of subpoenas at government expense.

5 IT FURTHER IS ORDERED that the Clerk of Court shall provide plaintiff with two  
6 copies of this order. Plaintiff is ordered to make the necessary arrangements to have one  
7 copy of this order attached to the check in the amount of the designated fee, by sending a  
8 copy of the order with the "brass slip" for the amount of the fee to Inmate Services for the  
9 Nevada Department of Corrections.

10 IT FURTHER IS ORDERED that, pursuant to 28 U.S.C. § 1915(b)(2), the Nevada  
11 Department of Corrections shall pay to the Clerk of the United States District Court, District  
12 of Nevada, 20% of the preceding month's deposits to plaintiff's account (in the months that  
13 the account exceeds \$10.00) until the full \$350.00 filing fee has been paid for this action. The  
14 Clerk of the Court shall send a copy of this order to the Finance Division of the Clerk's Office.  
15 The Clerk shall also send a copy of this Order to the attention of the Chief of Inmate Services  
16 for the Nevada Department of Corrections, P.O. Box 7011, Carson City, NV 89702.
