The Court, for the record, advises the parties that he is in receipt of a letter hand delivered today to Chambers from Mr. Herskovits, of the Western Environmental Law Center, which indicated that the Walker Lake Working Group and Mineral County will be withdrawing as participants of the mediation. The Court further advises the parties as to the purpose of this hearing and indicates that, as in past hearings, the proposed agenda of the United States would be used. There being no objections, the Court asks Ms. Schneider to proceed. Ms. Schneider reports that service efforts are continuing and a new mailing of approximately 290 persons should be sent out shortly regarding section 3D of the CMO. Ms. Schneider states that this is the second mailing concerning paragraph 3D. Ms. Schneider further advises the Court that there is no report to be authorized as she has been short staffed the past summer but hopes to have the Report compiled for the next hearing. Ms. Schneider reports the progress of the certificate of service status is ongoing and she and Ms. Bowman are working closely with the Clerk's office to resolve this matter. Ms. Schneider responds to Agenda Item 4, the status of the Mediation and reports that, in light of the recent withdrawal of several parties, the Tribe being one, the parties need to meet and discuss the situation with their clients. This issue will be addressed further at the next hearing. The Court next asks the parties for a date for the next hearing. The Court sets a status hearing for Friday, December 8, 2006, at 1:30 p.m. Counsel
