Re: Request to remove Alpine Property Management Inc. as defendant in civil action Docket #C-125, Subfile C-125-B, Case #73-12

To whom it may concern,

This letter is in response to the notice of lawsuit packet received from Susan L. Schneider, attorney for the United States of America vs. Walker River Irrigation District, naming Alpine Property Management Inc., as defendant. This letter was originally mailed to your office as well as Susan Schneider's office on December 9<sup>th</sup>, 2008.

Alpine Property Management Inc. owns and operates a small seasonal campground on the shore of Bridgeport Reservoir in Mono County, California. The notice indicates that Alpine Property Management Inc. is being included as a defendant in this case due to ¶3.c of the Case Management Order. Alpine Property Management Inc. does not fit into this class because Alpine Property Management Inc. does **not** hold a permit or certificate to pump groundwater issued by the State of Nevada and is **not** a domestic user of ground water within any of the Sub Basins listed; Further, Alpine Property Management Inc. can not be included in class ¶3.h as it is **not** a municipal provider of groundwater. I have reviewed all licenses and permits that Alpine Property Management Inc. holds and according to the Mono County Water System Administrator and the State of California, Alpine Property Management Inc. does **not** hold a permit to operate a municipal water system. It is important to note that the Mono County Water System Administrator and the State of California do issue permits for Municipal Water Systems and Alpine Property Management Inc. does not hold this permit nor does it operate a municipal system. I have found no other permits or water rights that Alpine Property Management Inc. holds that could possibly tie Alpine Property Management Inc. to this case.

Please let this letter serve as formal request to remove Alpine Property Management Inc. as defendant in civil action docket #C-125, Subfile C-125-B, Case #73-127 as it is clear that Alpine Property Management Inc. has been included in error. I trust the court will be advised and that no further information is needed at this time. Please advise me of the status of this request.
