On June 12, 2003, this Court approved the *Order Governing Mediation* (June 12, 2003). The United States of America, the Walker River Paiute Tribe, the Walker River Irrigation District, the State of Nevada, the State of California, Mineral County, Nevada, Lyon County, Nevada, Mono County, California, and the Walker Lake Working Group (collectively "Parties to the Mediation Process") had requested that the Court enter the *Order Governing Mediation Process* to assist in the implementation of their *Mediation Process Agreement* and bring their mediation process in these cases under the Court's supervision to the extent provided in the *Order Governing Mediation Process*. The Parties to the Mediation Process filed the original of their *Mediation Process Agreement*, including signature pages, with the Court.

The purpose of this filing is to file two additional signature pages to the *Mediation Process Agreement* with the Court and ask that they be filed with the original copy of the

Mediation Process Agreement. Attached are the original signature pages of the Bridgeport Indian Tribe and the Yerington Paiute Tribe. The provisions of the *Mediation Process Agreement* apply to and are binding upon these two “concurring tribes,” as set forth in Paragraph 9.3 of the *Mediation Process Agreement*.


