1 - The status of service efforts regarding service categories described in paragraph 3 of the CMO, plans to file additional status reports with the Court regarding these service efforts, and potential changes in the organization of status reports.

The Court is advised of the service efforts that are ongoing and that Ms. Schneider is planning to file the Fourteenth Status Report in September. Ms. Schneider also advises the Court and parties of potential changes in the organization of future status reports.

Ms. Schneider indicates that additional work still needs to be done regarding this issue.

# 6 - Subproceeding C-125C: service and other issues.

Mr. Herskovits advises the Court that continuing work is being done in compiling a comprehensive report regarding service. He suggests that, once that information is gathered, said report be filed, followed by any responses and replies. IT IS ORDERED that the proposed report is due August 29, 2008. Responses are due October 20, 2008. Replies are due November 20, 2008. The Court will then determine whether or not it is feasible to address both C-125-B and C-125-C at the next status conference.
