The United States of America (“United States”) hereby apprises the Court and the persons and entities identified herein of an error in service of process and the steps it has undertaken to correct that error.

Recently, the United States took steps to include in this action certain persons and entities identified by the State of California as riparian surface water users in the Walker River basin. This issue was discussed generally with the Court and parties during the last several status conferences. Our last mailing of service packages, dated August 17, 2012, seeking a waiver of service of process, included several entities with water rights in a nearby basin and not in the Walker River Basin. We were made aware of this error on August 29, 2012, and promptly attempted to ascertain its extent.

By this filing, we notify the Court that the following three entities do not fit within the Case Management Order’s service categories:

1. Snowcreek I HOA
2. Snowcreek II HOA
3. Snowcreek IV HOA

The three entities have filed Disclaimer of Interest forms (Doc ## 1751, 1752 and 1753). None of them has been included in our service reports, so we have not yet asked the Court to determine if service on them is complete.

We have provided a copy of this filing to these three entities and omitted their names from the case caption.
