The United States joins Mineral County's request to stay the motion to dismiss response deadline in subproceeding C-125-C. The Court has denied the request for counsel delegated to represent the United States to appear in this subproceeding. The Court's action also prevents the appearance of the same delegated counsel in any other aspect or subproceeding of this case. Until the Court rules on the United States' Motion for Expedited Reconsideration, delegated counsel are unable to appear in any aspect of this case - whether proceeding C-125, subproceeding C-125-B, or subproceeding C-125C.
