1 1. By Order dated October 16, 2014 (Dkt. 2099), the Court denied Motions to
2 Dismiss (Dkts. 1980; 1981) without prejudice to be refiled and served in accordance with the
3 Superseding Order Regarding Service (Dkt. 2100).

4 2. By Minute Order dated November 4, 2014 (Dkt. 2109), the Court scheduled oral
5 argument on refiled Motions to Dismiss for May 4, 2015 at 10:00 a.m.

6 3. On November 14, 2014, the United States served Unrepresented Parties as
7 directed by the Superseding Order, and pursuant to the Superseding Order, Unrepresented Parties
8 have up to and including January 13, 2014 to complete and return the Notice of Appearance and
9 Intent to Participate and/or Notice of Selecting Method of Service to Clerk of the Court (Dkt.
10 2116).

11 4. In anticipation of oral argument on May 4, 2015, the parties desire to establish a
12 schedule for the filing and briefing of Motions to Dismiss.

13 Based upon the foregoing, the Walker River Irrigation District, the California State
14 Agencies, the United States of America, the Walker River Paiute Tribe, Lyon County, Circle Bar
15 N Ranch, et al., Nevada Department of Wildlife, Mono County, California, and Mineral County,
16 Nevada, acting through their undersigned attorneys and subject to the approval of the Court,
17 stipulate as follows:

18 (1) Motions to Dismiss and supporting points and authorities shall be filed on
19 or before February 9, 2015;

20 (2) Responses in Opposition to Motions to Dismiss shall be filed on or before
21 March 20, 2015; and

22 (3) Replies in Support of Motions to Dismiss shall be filed on or before April
23 20, 2015.
