2 Schedule As Previously Amended (ECF 2676), the Walker River Irrigation District, Nevada
3 Department of Wildlife, Lyon County, Centennial Livestock and Mono County, Desert Pearl
4 Farms, LLC, Peri Family Ranch, LLC, Peri & Peri, LLC and Frade Ranches, Inc., the Schroeder
5 Group, and the California State Agencies (California State Water Resources Control Board,
6 California Department of Fish and Wildlife, and California Department of Parks and Recreation)
7 (herein, the “Principal Defendants”), report to the Court and the parties on the status of the
