1 The United States of America and the Walker River Paiute
2 Tribe, pursuant to Local Rule 150 and Rule 6(b), F.R.Civ.P.,
3 request an additional five months, up to and including
4 November 24, 1993, within which to complete joinder of additional
5 parties and service of process on claimants to the water of the
6 Walker River, and its tributaries, in accordance with the Order
7 of this Court, dated October 27, 1992, (Document No. 15).

8 As grounds for this request, the United States and the Tribe
9 emphasize the magnitude of this task. There appear to be
10 hundreds of water users in California and Nevada who claim water
11 from the Walker River and its tributaries. The United States and
12 the Tribe, although diligently working, have been unable to
13 complete the task of gathering together the current names and
14 current addresses of all water users in order to complete the
15 required joinder and service of process under Rules 19 and 4,
16 F.R.Civ.P.

17 WHEREFORE, the United States and the Walker River Paiute
18 Tribe request an extension of time up to and including
19 November 24, 1993, within which to complete the joinder of
20 parties and service of process in this matter.

21 NOW, THEREFORE, based upon the foregoing and subject to the
22 approval of the Court, the parties hereto, acting through their
23 respective counsel, hereby stipulate that the United States and
24 the Walker River Paiute Tribe may have an additional period of
25 time until November 24, 1993, in which to complete the joinder of
26 parties and service of process in this matter.
