ORDER FOR
ENLARGEMENT OF
TIME WITHIN WHICH
TO JOIN ADDITIONAL
PARTIES AND COMPLETE
SERVICE OF PROCESS
(FOURTH EXTENSION)

1 The United States of America and the Walker River Paiute
2 Tribe, pursuant to Local Rule 150, Rule 6(b), F.R.Civ.P., request
3 additional time, up to and including November 25, 1994, within
4 which to complete joinder of additional parties and service of
5 process on claimants to the water of the Walker River, and its
6 tributaries, in accordance with the Order of this Court, dated
7 October 27, 1992, (Document No. 15).

8 The Court granted the first extension by Order dated
9 February 23, 1993, (Document 19). Based on Stipulations of the
10 parties, additional extensions were granted by Orders dated June
11 14, 1993, (Document 20), and November 15, 1993, (Document 21).

12 As grounds for this request the United States and the Tribe
13 note that the United States filed a Motion for Instructions and
14 Order on April 7, 1994. The purpose of that motion is to
15 determine whether groundwater claimants in the Walker River Basin
16 are to be included as parties in these proceedings. If
17 groundwater claimants are included, then it will be necessary to
18 serve them with process.

19 On April 21, 1994, the parties stipulated that the time for
20 filing responses to the Motion for Instructions filed by the
21 United States would be extended to May 24, 1994. Additional time
22 will be needed to complete service of process following a
23 determination of whether or not groundwater claimants are to be
24 joined as parties.

25 WHEREFORE, the United States and the Walker River Paiute
26 Tribe request an extension of time up to and including
27

1 November 25, 1994, within which to complete the joinder of
2 parties and service of process in this matter.


