on claimants to the water of the Walker River, and its
tributaries, in accordance with the Order of this Court, dated
October 27, 1992, (Document No. 15).

The Court granted the first extension by Order dated February 23, 1993, (Document 19). Based on Stipulations of the parties, additional extensions were granted by Orders dated June 14, 1993, (Document 20), and November 15, 1993, (Document 21), May 23, 1994, (Document 25), November 17, 1994, (Document 36) and March 21, 1995, (Document 48).
