25 STIPULATION AND ORDER FOR EXTENSION OF TIME
26 WITHIN WHICH TO JOIN ADDITIONAL PARTIES AND COMPLETE
SERVICE OF PROCESS
27 (EIGHTH EXTENSION)

2 The United States of America and the Walker River Paiute
3 Tribe, pursuant to Local Rule 150, Rule 6(b), F.R.Civ.P., request
4 additional time, up to and including September 20, 1996, within
5 which to complete joinder of additional parties and service of
6 process on claimants to the water of the Walker River, and its
7 tributaries, in accordance with the Order of this Court, dated
8 October 27, 1992, (Document No. 15).

9 The Court granted the first extension by Order dated
10 February 23, 1993, (Document 19). Based on Stipulations of the
11 parties, additional extensions were granted by Orders dated June
12 14, 1993, (Document 20), and November 15, 1993, (Document 21),
13 May 23, 1994, (Document 25), November 17, 1994, (Document 36),
14 March 21, 1995, (Document 48) and September 25, 1995, (Document
15 49).

16 As grounds for this request for enlargement of time, the
17 United States and the Tribe note to the Court the magnitude of
18 this task and further note that counsel for all the undersigned
19 have stipulated to the extension. In addition, there has been an
20 internal review process going on within the federal government in
21 connection with this matter that the undersigned anticipated
22 would have been completed by the present time, but will require
23 additional time.

24 Also, since our last request for an extension, the Office of
25 Management and Budget has twice directed executive agencies,
26 including the Department of Justice, to modify their operations

1 in response to lapses in appropriations. Budget constraints and
2 cut-backs in other Departments of government, upon whom we rely
3 for case coordination, have resulted in a shift of work load
4 without additional staffing. At the moment, the Department of
5 Justice is funded on a one-week extension of the current
6 Continuing Resolution until March 22, 1996.

7 It is anticipated that service of process should be
8 completed sometime during this requested time extension.

9 WHEREFORE, the United States and the Walker River Paiute
10 Tribe request an extension of time up to and including
11 September 20, 1996, within which to complete the joinder of
12 parties and service of process in this matter.

13 NOW, THEREFORE, based upon the foregoing and subject to the
14 approval of the Court, the parties hereto, acting through their
15 respective counsel, hereby stipulate that the United States and
16 the Walker River Paiute Tribe may have an additional period of
17 time until September 20, 1996, in which to complete the joinder
18 of parties and service of process in this matter.






