

The Court hears the arguments of counsel regarding the Tribe's Motion to Stay Responses to and Court's Consideration of Motion for Order to Show Cause re Contempt, or, Alternatively, to Dismiss Without Prejudice (April 19, 2004, Doc. #680). The Court places its findings on the record. IT IS ORDERED that the Tribe's Motion to Stay is granted.

IT IS ORDERED that the Landolts' Motion for Order to Show Cause (March 10, 2004, Doc. #622) is stayed.

As to the Report of the United States Concerning Status of Service on Certain Persons and Entities (May 27, 2004, Doc. #697), the Walker River Irrigation District does not have objections. IT IS ORDERED that the relief requested is granted; Ms. Schneider will prepare an order.

Ms. Schneider's request to amend the summons form is granted.

Counsel shall contact the Clerk to ensure that the service list on the docket is accurate and manageable.
