

Rather than ask for repeated continuances, Mineral County believes that the most expedient manner to present its status to the Court is to summarize by number the problems in this last phase of the service. The intervening holidays so slowed the service by sheriffs in the counties that a few remain to be received. The documentation required by the Court has caused some problem in Mono County.

As a part of this status report, Mineral County will summarize how many persons must be dismissed, how many added and how many yet to be found for service. Due diligence has been completed on those need to be served by publication.
