1 On December 18, 2001, the Court held a hearing on Mineral County's *Amended Motion*  
2 *To Add and Dismiss Certain Parties* (the "Amended Motion"). Docket No. 377. As a result,  
3 the Court entered an order on December 19, 2001, Docket No. 397 (the "Dismissal Order"),  
4 that addresses the Amended Motion.

5  
6 At the December 18, 2001 hearing, the Court directed the parties to file any motions to  
7 reconsider the Dismissal Order by January 15, 2002. The Walker River Irrigation District does  
8 not specifically request the Court to reconsider any portion of the Dismissal Order, however,  
9 the District offers the following observations for the Court's consideration. If the Court deems  
10 it necessary, the parties may discuss the following information at the hearing scheduled for  
11 February 25, 2002.

12  
13 **9. Beagle, Billy Roy and Thelma**

14 The District agrees that Billy Roy Beagle and Thelma Beagle should be dismissed. The  
15 District's current assessment records, however, indicate that Thomas Bobrick and Ruth Ellen  
16 Bobrick reserved the water rights appurtenant to lands owned by Robert D. Webb and Linda K.  
17 Webb. Therefore, the District questions whether the Webbs should remain as defendants. *See*  
18 Dismissal Order at p. 3, lns 24 - 25.

19 **12. Day, Charles E. and Lucille M. Day**

20 The District's review indicates that Weaver Properties, LLC is not currently listed in  
21 the Caption and, therefore, should be added to it. *See* Dismissal Order at p.6, ln. 4.

22 **29. Gable Family Trust**

23 The District's review indicates that Don Ray Gable, individually, is not currently listed  
24 in the Caption and, therefore, should be added to it. *See* Dismissal Order at p.6, lns. 25 - 26; p.  
25 18, ln. 14.

26 **31. Giorgi, Daniel Elmo**

27 The District's review indicates that Keith Savage and Virginia Savage are not currently  
28 listed in the Caption and, therefore, should be added to it. *See* Dismissal Order at p.7, ln. 7.

1 **39. King, Roy**

2 The District's review indicates that the William S. Rauber and Charlotte F. Rauber  
3 Declaration of Trust, William S. Rauber, Trustee,<sup>1</sup> and the Morgan Family 1996 Trust, James  
4 R. Morgan, Trustee, are not currently listed in the Caption and, therefore, should be added to it.  
5 See Dismissal Order at p.9, lns. 2 - 4.

6 **46. Minister, Rose Alice / Bolton-Rose Trust**

7 The District's current assessment records indicate that Bolton Francis Minister is the  
8 sole trustee of the Bolton Rose Trust. See Dismissal Order at p. 10, lns. 1 - 2; p. 19 at lns. 9 -  
9 10.

10 **72. Smith, Grant and Gaila**

11 Steve Singer and Linda Singer should be dismissed as ordered by the Court with respect  
12 to entry No. 71, Steve and Linda Singer. See Dismissal Order at p. 14, lns. 17 - 18 ("Mineral  
13 County seeks to dismiss Steve and Linda Singer").
