Dear Treva:

My office has reviewed the revised caption (the "Revised Caption") that you provided to the parties on March 4, 2002. In this review, we compared the contents of the Revised Caption with the contents of the caption filed by Mineral County with the Court on January 12, 1998 (the "Original Caption"). The contents of the Revised Caption differ substantially from those of the Original Caption. I have attempted to outline those differences in the comparison document (the "Comparison Document") attached hereto.

Section 1 of the Comparison Document contains names that appear differently in the Revised Caption as compared to how those names appeared in the Original Caption. The shaded names have not been the subject of any court order since Mineral County filed the Original Caption, however, for some reason they have been altered in the Revised Caption. For the most part, these discrepancies involve the deletion of individuals' middle initials, however, several other discrepancies are present with respect to the shaded names appearing in this category. For example, in some instances the "Jr." has been dropped from the name in the Revised Caption.2

The remaining names listed in Section 1 of the Comparison Document (not shaded) include those names that have been the subject of court order and for some reason have been altered. For example, the Court substituted Richard Taylor Adams pursuant to its December 19, 2001 order, however, the name appears as Richard Adams.

Section 2 of the Comparison Document includes names that were listed on the Original Caption but do not appear on the Revised Caption. With respect to these names, there appears to be no reason as to why they have been deleted, i.e., they have not been dismissed pursuant to Court order.

Section 3 of the Comparison Document includes names that appear on the Revised Caption but were not listed on the Original Caption.³ With respect to these names, there appears to be no reason why they have been added, i.e., they have not been substituted into this matter pursuant to Court order.

Section 4 contains the names of parties substituted by the court or names involving an amendment to the Original Caption that are not present on the Revised Caption.

Section 5 contains the names of parties dismissed by the Court's March 2, 1999 order that remain in the Revised Caption for some reason.

In reflecting upon the February 25, 2002 Status Conference and in conducting the comparison between the Original and Revised Captions, it became obvious that it would be advantageous to have a written order entered with respect to the rulings made at the February 25 Status Conference. Therefore, I have prepared a proposed order that I believe reflects the contents of the Court's rulings at the February 25, 2002 Status Conference. I have enclosed a copy of the proposed order with this letter for your review and will request that the Court enter the order, with any necessary modifications, at the hearing on Wednesday.

Finally, in the Walker River Irrigation District's Response to Mineral County's Amended Motion to Add and Dismiss Certain Parties (the "District's Response") (Docket #386), I pointed out Mineral County's previous representation that it intended to move to dismiss fifteen parties but had failed to do so. See District's Response at 26, 27. Of those

On April 3, 2000, the Court filed an Order Concerning Status of Service on Defendants (Doc. #327). Among other things, that order found that Mineral County had either failed to properly serve its Intervention Documents or the information contained in the record was insufficient to establish proper service with respect to 170 proposed defendants. The order also listed the names of these 170 proposed defendants. See Doc. # 327 at 3-6.

By order dated December 18, 2001, the Court directed counsel for the Walker River Irrigation District (the "District") to identify the remaining proposed defendants, from the 170 names listed in the Order Concerning Status of Service, for which the District continued to object with respect to service by Mineral County of its Intervention Documents. Doc # 396. The District filed this list as directed by the Court on January 31, 2002. Doc. #___.

A hearing on the District's objections concerning service of Mineral County's Intervention Documents was held by the undersigned Magistrate Judge on February 25, 2002. Present in person were Dale Ferguson on behalf of the District, Linda Bowman on behalf of the United States Board of Water Commissioners and Treva Hearne on behalf of Mineral County. Present by telephone were Alice Walker on behalf of the Walker River Paiute Tribe, Susan Schneider on behalf of the United States and Michael Neville on behalf of the California Attorney General. Based upon the written submissions and oral arguments of counsel at the February 25, 2002 hearing, the court finds and orders as follows:
