1           A.       On April 30, 2001, Mineral County filed an Amended Motion to Add and  
2 Dismiss Certain Parties (the "Amended Motion") (Doc. #377). After briefing by the parties,  
3 the Court conducted a hearing on the Amended Motion on December 18, 2001.

4           B.       By order dated December 19, 2001 the Court granted in part and denied in part  
5 the Amended Motion. Docket #397.

6           C.       By order dated February 25, 2002, the Court ordered Mineral County to  
7 circulate an amended caption in this matter by March 4, 2002. Docket #403. Mineral County  
8 circulated an amended caption (the "Amended Caption") on March 4, 2001.

9           D.       On March 18, 2002, the Walker River Irrigation District (the "District")  
10 circulated a letter (the "District Letter") describing the discrepancies between the Amended  
11 Caption and the caption filed by Mineral County with the Court on January 12, 1998 (the  
12 "Original Caption"). Those discrepancies were outlined in detail in a comparison document  
13 (the "Comparison Document") attached to the District Letter. The Comparison Document  
14 separated the discrepancies between the two captions into 5 categories or sections as follows:

- 15           1.       Section 1 contained names that appeared differently in the Amended Caption as  
16                    compared to how those names appeared in the Original Caption. For example,  
17                    in many instances the middle name or initial of an individual had been deleted  
18                    for some reason in the Amended Caption.
- 19           2.       Section 2 contained names of parties listed in the Original Caption but not in the  
20                    Amended Caption and for which the Court had entered no order of dismissal.
- 21           3.       Section 3 contained names of parties listed in the Amended Caption but not in  
22                    the Original Caption and for which the Court had entered no order adding or  
23                    substituting the party.
- 24           4.       Section 4 contained the names of parties added or substituted into the action by  
25                    Court Order, or amendments to the Caption by Court Order, that were not  
26                    present in the Amended Caption.
- 27           5.       Section 5 contained the names of parties dismissed by the Court's March 2,  
28                    1999 order and that remained in the Amended Caption.

1           E.       The District Letter also raised two additional matters. First, a proposed written  
2 order describing the contents of the Court's rulings made at the February 25, 2002 Status  
3 Conference was attached to the District Letter. It also informed Mineral County that the  
4 District would request the Court to enter the proposed order at the next Status Conference.

5                       Second, the District Letter informed Mineral County that it had not served or  
6 moved to dismiss eleven parties that the County had previously represented would be the  
7 subject of a motion to dismiss. See Docket #396 at 26, 27. It also stated that the District would  
8 like to address the status of these eleven parties at the next Status Conference.

9           F.       By order dated March 20, 2002, the Court ordered counsel for Mineral County,  
10 the District and other interested parties to meet and confer to resolve the discrepancies raised  
11 by the District Letter. A subsequent order also required counsel to file a joint status report by  
12 April 26, 2002, to advise the Court of the results of this meeting.

13           G.       Counsel for the United States Board of Water Commissioners, United States of  
14 America, Mineral County and the District met on April 2 and 3 to discuss the discrepancies  
15 between the Amended Caption and the Original Caption.

16           H.       On April 22, 2002, the District's counsel circulated a proposed draft of a joint  
17 status report for consideration by other counsel. The cover letter accompanying the draft report  
18 asked counsel to return comments as soon as possible because counsel for Mineral County had  
19 stated that she would be out of the state and therefore unavailable after April 23, 2002. See  
20 Exhibit 1 attached hereto. Counsel for the United States Board of Water Commissioners and  
21 the United States of America suggested and counsel for the District made minor revisions to the  
22 draft joint status report.

23                       By letter dated April 23, 2002, counsel for Mineral County informed counsel for  
24 the District that the proposed draft report was not satisfactory to the County for several reasons.  
25 See Exhibit 1 attached hereto. Also by letter dated April 23, 2002, the District responded to the  
26 concerns raised by Mineral County's letter. *Id.* The District's April 23, 2002 letter also  
27 requested that counsel for Mineral County contact the District's counsel to further discuss the  
28 contents of the joint status report. *Id.* By letter dated April 25, 2002, the District's counsel

1 circulated a further revised draft report to counsel and again requested that counsel for Mineral  
2 County contact counsel for the District to discuss the contents of the draft status report. *Id.*  
3 Thereafter, counsel for Mineral County did not contact the District's counsel and, therefore, the  
4 District has filed this status report with the Court.

5 I. As a result of the April 2 and 3 meeting, counsel for the United States Board of  
6 Water Commissioners and the District currently believe that most of the discrepancies between  
7 the Amended Caption and the Revised Caption, as set forth in the Comparison Document, have  
8 been resolved. The discussion below follows the sections from the Comparison Document  
9 attached to the District Letter as discussed in Paragraph D above.

- 10 1. Section 1: Mineral County has agreed to revise the Amended Caption to  
11 conform to the Original Caption with respect to the discrepancies in this  
12 section.
- 13 2. Section 2: Mineral County has agreed to revise the Amended Complaint  
14 to include the names of the parties listed in the Original Caption for  
15 which no order of dismissal has been entered, as listed in this section.
- 16 3. Section 3: See discussion in Paragraph J below.
- 17 4. Section 4: Mineral County has agreed to revise the Amended Caption to  
18 include the names of the parties added or substituted into the action by  
19 Court Order, as listed in this section.
- 20 5. Section 5: Mineral County has agreed to revise the Amended Caption to  
21 delete the names of parties dismissed by the Court's March 2, 1999,  
22 order, as listed in this section.

23 A copy of the most recent version of the Amended Caption received by the District from  
24 Mineral County is attached hereto as Exhibit 2.

25 J. The District and Mineral County do not agree with respect to the parties listed in  
26 Section 3 of the Comparison Document attached to the District Letter. Those parties involve  
27 names listed in the Amended Caption but not listed in the Original Caption and for which the  
28

1 Court has entered no order substituting or adding the parties. It is unknown whether Mineral  
2 County seeks to substitute these parties in place of another party or to simply add these parties.

3 Mineral County argues that it should be allowed to add (or substitute) these  
4 names to the Amended Caption because they allegedly appear on the current assessment roll of  
5 either the District or the United States Board of Water Commissioners (the "U.S. Board").  
6 Mineral County has served most but not all of these parties. Currently, the names of these  
7 parties do not appear on the Amended Caption attached hereto as Exhibit 2.

8 A review of the current assessment roll of the District and U.S. Board indicate  
9 that some, but not all, of these names do appear thereon. Nevertheless, the District and U.S.  
10 Board argue that these names should not be added or substituted into the Amended Caption  
11 unless and until they have been made the subject of a proper motion to add or substitute and the  
12 Court has in fact ordered their addition or substitution. Without a proper motion of this nature,  
13 parties could be substituted or added into this matter by Mineral County without the Court,  
14 District, U.S. Board or any other party having notice or knowledge of the substitution or  
15 addition. Parties could be substituted without the Court knowing if the proper corresponding  
16 party has been dismissed. Finally, merely because a name appears on the assessment list of the  
17 District or U.S. Board does not necessarily mean that the named individual or entity holds title  
18 to a water right and should, therefore, be substituted or added into the action.

19 K. As stated above, the District Letter also contained a proposed order setting forth  
20 the rulings of the Court made at the February 25, 2002 status conference. By letter dated April  
21 18, 2002, Mineral County informed the District that it objected to Section D of the proposed  
22 order because some of the names listed in that section had been served. As a result of the  
23 District's review of Mineral County's letter, it appears that the parties named in Section D of  
24 the proposed order currently fall into three categories. The first category involves parties that  
25 Mineral County and the District agree have not yet been served and, therefore, should remain in  
26 Section D of the Proposed Order. The second category involves parties that the District and  
27 Mineral County agree have been served and, therefore, should be moved from Section D to  
28 Section C of the Proposed Order.

1           The third category involves approximately fifteen parties for which the District  
2 and Mineral County disagree as to whether service is complete. With respect to these parties,  
3 contested issues remain with respect to whether service has or has not been properly effected.  
4 The District will file a position paper addressing the District's position with respect to the status  
5 of service on these individuals by no later than April 30, 2002. The District will request that  
6 the Court rule with respect to the status of service on these approximately fifteen parties at the  
7 Status Conference on May 3, 2002.

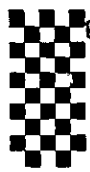




In my opinion the Magistrate meant for us to settle certain of these issues between us. We may ask him to make policy decisions like whether I should have to go back and prove that people on your list are water rights holders or not in order to be added to the caption, but I don't think he wants to make decisions on any further service matters that we could obviously settle if you look at the papers I gave you and decide if you are going to argue with my service or not.

In paragraph numbered 8, it says "add these names to the amended caption because they may appear on the District's current assessment role." They do appear. Why would I even suggest adding them if they didn't appear on the District's role or on the Board's role? Moreover, you can check that so that we don't have to say "may." The magistrate will think we haven't even looked at the role to check that issue. That would not be in our best interest.

Finally I think it is important that we add that Mineral County made this caption from the list at the WRID and the Board, given to it on disc by the two entities. If after five years of service Mineral County can't find any reference to these names, then they should be stricken from the list. The verification that they don't have water rights is to check with the United States of America. The fact is that caption was not sent from the throne. It was

simply the names that we placed on the caption prior to checking the records at the Clerks offices. The names were just a place to begin. They simply weren't chiseled in stone from any higher authority. Given the state of your records and the little faith you have in them because some non-attorney sends you deeds, I think we are attributing far more credence to that original caption that is due. I want to put some of this language in Paragraph 8 so the Magistrate will know that some of these names just need to be deleted because they weren't good in the first place and that is why Mineral County can't prove where their water rights went.

Dear Treva:

I have reviewed your letter dated April 23, 2002 which I received via facsimile at 10:39 A.M. this morning. We obviously disagree concerning the intent of the Magistrate with respect to his decision making role and as stated in his recent orders. In his March 18, 2002, order, the Magistrate directed counsel for the District, Mineral County and other interested parties to personally confer to resolve the discrepancies raised by my March 18, 2002, letter to you. He also directed those counsel to advise him of the results of this consultation through the filing of a joint status report. I believe my proposed joint status report (the "Proposed Report") satisfies the Magistrate's directives and I have already incorporated minor comments concerning the contents of the Proposed Report forwarded to me by Linda Bowman and Susan Schneider. Nevertheless, I will address the issues raised by your letter of this morning.

You allege that "we could obviously settle" disputes over the status of service on certain parties if I would only "look at the papers" provided by your office. You are apparently referring to the contents of Paragraph 9 of the Proposed Report. I have reviewed your letter of April 18, 2002 and the attached service documents as well as other relevant service documentation. My review indicates that the parties named in Section D. of the proposed order attached to my letter of March 18, 2002 (the "Proposed Order") fall into three categories. The first category involves parties that Mineral County and the District agree have not yet been served and, therefore, should remain in Section D. of the Proposed Order. The second category involves parties that the District and

Mineral County agree have been served and, therefore, should be moved from Section D. to Section C. of the Proposed Order.

The third category involves approximately 15 parties for which the District and Mineral County disagree as to whether service is complete. With respect to these parties, I believe that legitimate issues still remain with respect to whether service has or has not been effected and that the Magistrate should rule on those issues. Ms. Bowman suggested that Paragraph 9 of the Proposed Report be revised to provide for the filing of position papers with the Court, prior to the May 3, 2002 status conference, to address disputes over the status of service with respect to these approximately 15 parties. I have no objection to this revision and will most likely file something of this nature. We may want to revise Paragraph 9 of the Proposed Report to further explain the status of those persons listed in Section D. of the Proposed Order to the Magistrate.

In reference to Paragraph 8 of the Proposed Report, you allege that all parties listed in Section 3 of the attachment to my March 18, 2002, letter appear on the District's current assessment roll. That is simply not true. More importantly, however, I believe that other reasons exist for not allowing Mineral County to simply add parties to the caption merely because they appear on the District's current assessment roll. I would like to have this issue heard and then decided by the Magistrate Judge. We may also want to revise Paragraph 8 of the Proposed Report to further define the dispute over those parties listed in Section 3 of the attachment to my March 18, 2002, letter.

Finally, you argue that accuracy concerning the contents of the caption is really not that important and that Mineral County should be allowed to simply delete names from the caption at will. I strongly disagree. Mineral County seeks to prosecute claims that may negatively impact the real property rights of numerous individuals and entities. Their proper identification and joinder is mandatory. As a result, the Court has required Mineral County to identify and then serve, pursuant to FRCP 4, all claimants to the waters of the Walker River and its tributaries. With respect to the issue of Mineral County unilaterally dismissing parties, the Court has already ruled as follows:

Normally, it is true that a plaintiff exercises a fair degree of control over what entities or individuals are named as defendants in a case. In many respects, Mineral County is in the position of a plaintiff--it has been required to serve all defendants with notice of its claims. However, we cannot allow Mineral County complete freedom here to determine who the proper defendants are or should be. This case is essentially an action in rem to quiet title to property--that property being the water (or rather, the right to take water) of the Walker River and its tributaries. Minute Order of April 1, 1997 (#99). Without all the owners of the property properly joined in the case as defendants, any reallocation of water rights that might

result from the case could be subject to future attack. Order of June 4, 1998 (#210). Thus we have not dismissed any defendant from the case solely on Mineral County's representations that that defendant has no water rights.

Order dated March 2, 1999 (Docket # 257) at 4 (emphasis added). This language makes it clear that the dismissal of any proposed defendant must be based on something more than Mineral County's mere representation that the party should be dismissed..

For the reasons set forth above, I do not believe that the Proposed Report should be modified as suggested by your letter of this morning. Nevertheless, in an effort to comply with the Magistrate's order, I will discuss any specific suggested changes to the language of the Proposed Report if you provide those changes to me in writing. In addition, after reflecting upon the contents of the Proposed Report, I may want to make some revisions to better describe how we resolved the discrepancies set forth in my March 18, 2002, letter.

Please contact me after you have reviewed this letter so that we may further discuss the contents of the joint status report that must be filed with the Court no later than April 26, 2002.


