I.

**INTRODUCTION AND CHRONOLOGY**

This case is based upon a request to further adjudicate the waters of the Walker River, an interstate stream, originating in California and flowing to its terminus into Walker Lake, Mineral County, Nevada. Walker River Irrigation District ("WRID") is a legislatively created irrigation district, according to NRS, Section 533.300, that stores and regulates allocation of the waters of the Walker River to its members for agricultural irrigation and a golf course.

A decree was entered by the Court regarding the allocation of water rights in 1935. *U.S. v. Walker River Irrigation District*, 11 F.Supp. 158 (D.Nev. 1935). This decree was enforced by WRID until a separate federal Watermaster was appointed.

WRID manages two reservoirs on the Walker River - Bridgeport and Topaz (See C-125-A, a subfile of the present case.) Some time in the last years of the 1980's, WRID so managed the Bridgeport dam and water flow allotments that Bridgeport reservoir was dewatered, which resulted in a large fish kill (C-125-A). The State of California invoked California state law requiring a minimum pool be maintained in Bridgeport Reservoir to preserve fish habitat. Large fines were levied against WRID for its management of the reservoir. WRID filed this action under the Court's continuing jurisdiction of the 1936 decree to determine if California's minimum pool requirement prohibited WRID from executing its obligations under the 1935 decree. This action was given a sub-file of C-125-A for Court convenience.

1  
2 After this action was filed, the Walker River Paiute Tribe, joined by the United  
3 States of America as its trustee, filed for intervention in order to claim additional water  
4 rights not granted by the 1935 decree. This action was given a sub-file number of C-125-  
5 B.

6 In October 1994, Mineral County, Nevada, filed a Request to Intervene in this  
7 action in order to request minimum flows of the Walker River to reach their terminus to  
8 preserve the Lake's fishery from eminent extinction since the Walker River is nearly the  
9 only source of recharge for Walker Lake. On or about March 10, 1995, pursuant to the  
10 Order of the Court, Mineral County, Nevada filed an amended Complaint in Intervention.  
11 On February 9, 1995, the Federal District Court of the District of Nevada issued an Order  
12 establishing the manner, method, and timing of service of process on the water rights  
13 holders of the Walker River. Mineral County, Nevada, was given until May 10, 1995,  
14 within which to complete service on those water rights holders.  
15  
16

17 Pursuant to Federal Rules of Civil Procedure, Rule 4, Mineral County had mailed a  
18 request for waiver of service to persons on lists from the Recorders of Deeds in the  
19 County where the Walker River is located and who had recorded water rights, plus to  
20 persons on a list of secondary permit holders furnished by the Walker River Irrigation  
21 District and the Watermaster. Mineral County received a few waivers from water rights  
22 holders, but because Walker River Irrigation District ("WRID") and the Walker River  
23 Users Group ("WRUG") had circulated newsletters instructing water rights holders not to  
24 execute the waivers, the return of service by waiver was a small percentage of what was  
25 believed to be the entire group of water rights holders. Therefore, on June 30, 1995,  
26  
27  
28

1 Mineral County, Nevada, filed a Motion for Sanctions against WRID and WRUG for  
2 interference with the service.  
3

4 On August 16, 1995, the Court ordered Mineral County to make personal service  
5 on the Walker River water rights holders if no waiver of service had been executed and  
6 returned. Over 1,000 man-hours of volunteer time and an expenditure of over \$79,000.00  
7 by Mineral County and an additional expenditure by the Walker Lake Working Group of  
8 \$10,000.00, were consumed in completing personal service.  
9

10 On February 1, 1996, Mineral County, Nevada, filed with the Court the proof of  
11 service forms from the personal service. At that time Mineral County informed the Court  
12 that it had completed service to the best of its ability since the list given by the Walker  
13 River Irrigation District was antiquated and contained many persons who had sold their  
14 rights or who were deceased. Mineral County requested that the Court allow it to  
15 consider its service complete and serve nothing further pursuant to FRCP, Rule 5, and if  
16 the Court believed that further service was required, that the service be accomplished by  
17 publication. On March 25, 1997, The Court denied the Motion and did not speak to the  
18 request for publication.  
19

20 On April 24, 1996, Mineral County, Nevada, appealed the Court's denial. The 9<sup>th</sup>  
21 Circuit Court of Appeals in dismissing the appeal noted that such a case could be ripe for  
22 publication of service.  
23

24 On February 22, 1997, Mineral County, Nevada, moved the Court for the right to  
25 make service upon the remaining holders of water rights in the Walker River by  
26 publication. The Court granted Mineral County's request on April 1, 1997, as to all  
27  
28

1  
2 holders of water rights in the Walker River that had not been personally served or  
3 executed waivers except those who were appurtenant water rights holders in the State of  
4 California.

5 On April 25, 1997, Mineral County, Nevada, filed a Request for an Order  
6 Approving the Documents for Publication. Heretofore, Mineral County had proceeded to  
7 serve documents and without notice WRID and WRUG had frustrated the efforts at  
8 service by an alleged contention regarding the documents served. In an abundance of  
9 caution Mineral County requested that the Court approve the documents for publication  
10 prior to publication in order to predetermine any further contentions by WRID and  
11 WRUG.  
12

13 Prior to the Court's response the parties agreed that a Notice in Lieu of Summons  
14 was more appropriate for publication of service. The parties had heretofore complained  
15 that service of the Motion for Intervention, the Amended Complaint in Intervention and  
16 the Motion for Preliminary Injunction were confusing and too many pages for the persons  
17 served to comprehend and, thus, prepare a meaningful response. Pursuant to that  
18 agreement, the parties had a telephone conference with the Honorable Edward C. Reed  
19 who determined that the issue of completion of service should be referred to this Court for  
20 resolution.  
21  
22

23 In the meantime and pursuant to the Court's order, water rights holders that have  
24 appurtenant water rights in the State of California have been personally served if they  
25 could be found. Mineral County, Nevada, states that all personal service that could be  
26 accomplished has been. Yet Mineral County, Nevada, believes that certain secondary  
27  
28

1 permit holders may exist that cannot be identified. The only means by which those  
2 unascertainable persons may be served is by means of publication. As set out more fully  
3 herein, the persons who may require further notice of this proceeding hold water rights but  
4 have not recorded with the County Recorder of Deeds, do not have ascertainable  
5 addresses or have replaced dead persons unbeknownst to any party with a list of water  
6 rights holders.

12 II.

13 MINERAL COUNTY HAS THE MOST UP-TO-DATE  
14 LIST OF WATER RIGHTS HOLDERS IN THE WALKER RIVER  
15 AND THIS LIST CONFIRMS THAT UNIDENTIFIED WATER  
16 RIGHTS HOLDERS EXIST.  
17  
18

19 Mineral County, Nevada, has prepared a list of those persons believed to hold  
20 water rights in the Walker River. This list has been updated as much as possible by  
21 confirming persons that were found who received service and acknowledged that they had  
22 water rights in the Walker River. (See Affidavit of Kelvin J. Buchanan) The list still  
23 reflects persons that cannot be found. Moreover, because many names list as the only  
24 address a Post Office Box, and because persons are known to be deceased but still appear  
25 as record title holders, Mineral County believes that other persons rightfully hold water  
26  
27  
28



1  
2 rights but have not changed the title, nor have they been listed in any manner elsewhere as  
3 a water rights holder. Mineral County believes that certain water rights holders who have  
4 derived their rights from secondary permits through Irrigation Districts or Ditch  
5 Associations or for some other reason have not recorded or updated recordation of water  
6 rights and, therefore, do not appear.

7  
8 The records of the county recorder of deeds may not list the most current owner of  
9 water rights, particularly if the water rights are secondary rights. Mineral County has a list  
10 with the most current holders of water rights from the County recorders of deeds in the  
11 counties where the Walker River flows. Mineral County has the first list and second list  
12 provided by WRID. Mineral County has the list furnished by the Watermaster. Mineral  
13 County has the list of appurtenant water rights holders of water rights in California as  
14 furnished by the State Water Resources Control Board and the Attorney General. Mineral  
15 County requests that the Court recognize its list as the most current. Mineral County is  
16 the only party that has attempted service. The United States and the Walker River Paiute  
17 Tribe have not begun service of its claim at this time. WRID was not required to serve  
18 any other parties when it instituted this action. The State of Nevada was not required to  
19 serve any parties when it requested intervention nor was Cal Trout required to serve any  
20 parties for its intervention. Mineral County is in the best position to know what parties  
21 exist, who can be served and who cannot be identified. Based upon this knowledge  
22 Mineral County respectfully requests that the Court allow publication of a Notice in Lieu  
23 of Summons in the newspapers identified by the Honorable Edward C. Reed in his order  
24 of April 1, 1997.  
25  
26  
27  
28

1  
2 The Office of the State Engineer of the State of Nevada has totally delegated or  
3 failed for other reasons to have any record in its offices of the water rights holders of the  
4 Walker River. There is no possibility of verifying the list by a master list held by the State  
5 Engineer. The Watermaster has a list of 74 entries. One is the Walker River Irrigation  
6 District. In other words, by notifying the Walker River Irrigation District, not the  
7 individual members, the Watermaster believes that it has accomplished sufficient notice of  
8 any of its mandates. WRID has admitted that it does not have a list of all water rights  
9 holders in the Walker River, since its membership does not include all water rights holders,  
10 it does not keep its list up-to-date, and it has no authority in California. WRID, the  
11 Watermaster, nor the State Engineer of Nevada can address the issues of service on the  
12 water rights holders because they simply have no basis for assessing the problems with  
13 service on the water rights holders since none of these entities have made a colorable  
14 effort to determine how many water rights holders there are and how they hold their  
15 rights. Mineral County has spent the past two years in extensive search and work on the  
16 service and is in the only position to certify a list or know that such a list cannot be  
17 certified because of unidentified parties. Mineral County is the only party that has  
18 undertaken this endeavor and has expended substantial resources to derive this list and  
19 understand its failings. The other parties are simply ignorant as to the circumstances and  
20 Mineral County requests that the Court weigh that lack of knowledge with the active  
21 search and service efforts of Mineral County.  
22  
23  
24

25 The fact that WRID and WRUG have from the beginning attempted to interfere  
26 with the service efforts of Mineral County should also go to the weight of any comments  
27  
28

1 by these parties. The State of Nevada has throughout this proceeding adopted the  
2 arguments and position of WRID and has proffered no position of its own. The United  
3 States of America has not begun the service of process for its amended claim and asked  
4 for a six month extension. Mineral County is the only party whose argument and  
5 statements have substance and meaning regarding the service of process in this case.  
6

10 III.

11 PUBLICATION IS APPROPRIATE UNDER  
12 NEVADA LAW FOR ACTIONS INVOLVING  
13 REAL ESTATE  
14

15 A.

16 THE MOST CRITICAL ELEMENT OF  
17 SERVICE OF PROCESS IS THE  
18 FACTOR OF ADEQUATE NOTICE  
19 TO THE PARTY BEING SERVED  
20  
21  
22

23 Generally, notice of water adjudications is provided by State law. The United  
24 States Congress believed that the law of the State for the purpose of water adjudications  
25 was paramount to the interests of the United States in water law matters. The Congress  
26 has waived the sovereign immunity of the United States and allowed it to be made a party  
27

1 to state court water adjudications, See, 43 U.S.C., Section 666. The Western States that  
2 provide for water adjudications have adopted service by publication of notice in the  
3 newspapers of general circulation where the stream is located as sufficient notice to the  
4 water rights holders of the stream being adjudicated. See NRS, Section 533.095,  
5 Likewise, Oregon, ORS, Section 539.021; Idaho Code 42-1408(2)(b); California Water  
6 Code, Section 2527; Colorado Revised Statutes 37-92-401; Arizona, ARS, Section 45-  
7 253.  
8

9  
10 Recently, the Ninth Circuit Court of Appeals reaffirmed the priority of State law in  
11 water adjudications in a case in Oregon. In that case, the Court determined that the  
12 United States was subject to the State assessment and to the other rules adopted by the  
13 State of Oregon for water adjudications.  
14

15 As was traditional in Western states, the relative rights of various claimants  
16 to water from a river system were determined piecemeal, as conflicts arose,  
17 in traditional lawsuits in equity (citations omitted). As the West became  
18 more populated, conflicts over water rights increased. As the interrelation  
19 of water rights became more apparent, a dilemma emerged: the nature of  
20 traditional civil litigation made joinder of the hundreds or thousands of  
21 claimants to a river system extremely cumbersome and inefficient. . . As it  
22 became clear that the necessary scope of comprehensive water rights  
23 adjudication could not be accommodated by traditional litigation  
24 procedures, Western states began to develop alternate, statutory  
25 adjudication systems for the mass determination of the rights of all  
26  
27  
28

1 claimants in a river system.. ..

2  
3 *U.S. v. State of Oregon, supra*, 44 F.3d 758,763, 764 (9<sup>th</sup> Cir. 1994).

4 Clearly, State law allowing publication of notice of the adjudication of water rights  
5 has passed court scrutiny as sufficient and adequate notice. Thus if publication of notice is  
6 adequate and sufficient notice from the outset of the litigation, then certainly publication  
7 to complete service after the personal service that has been accomplished in this matter by  
8 Mineral County is more than sufficient.  
9

10 The Court has already approved the publication of notice.(See Order of April 1,  
11 1997 attached hereto). The issue before this Court is to determine if the Notice in Lieu of  
12 Summons (attached hereto) is adequate notice to the parties of the litigation. This Notice  
13 has been circulated for comments and Mineral County respectfully submits the Notice as  
14 drafted by WRID as the Notice that it agrees to publish in the newspapers of general  
15 circulation as identified by the Honorable Edward C. Reed.  
16

17 B.

18 NEVADA RULES OF CIVIL PROCEDURE

19 RULE 4(e)(1)(ii) PROVIDES FOR

20 PUBLICATION OF NOTICE

21 Nevada Rules of Civil Procedure, Rule 4, provides as follows:  
22

23 (4)(e)(ii). Property. In any action which relates to, or the subject  
24 of which is, real or personal property in this state in which such  
25 person defendant or corporation defendant has or claims a lien or  
26 interest, actual or contingent, herein, or in which the relief  
27

1  
2 demanded consists wholly or in part of excluding such person or  
3 corporation from any interest therein, and the said defendant resides  
4 out of the state or has departed from the state, or cannot after due  
5 diligence be found within the state, or conceals himself to avoid the  
6 service of summons, the judge or justice may make an order that  
7 the service be made by the publication of summons; said service by  
8 publication shall be made in the same manner as now provided in all  
9 cases of service by publication.  
10

11 Certainly, Mineral County has exercised due diligence to ascertain, find and serve  
12 the potential water rights holders of water rights in the Walker River. Mineral County has  
13 personally served a significant number of potential water rights holders. Publication of  
14 service will assure that service of process is complete as to all parties.  
15

16 For the above-stated reasons, Mineral County, Nevada, respectfully requests that  
17 this Court issue an Order of Publication for the Notice in Lieu of Summons and that  
18 Mineral County's service be considered complete upon proof of publication.  
19



I, Kelvin J. Buchanan being duly sworn, hereby state that:

1. I am a Professional Engineer registered in the State of Nevada and a principle  
with the firm of HB Engineering.

1  
2 2. I have submitted previous affidavits regarding service in C-125-c. One of these  
3 affidavits pertains to the spreadsheet containing names and addresses of Walker River  
4 Water Rights holders acquired from the State of California, United States Board of Water  
5 Commissioners and the Walker River Irrigation District which were compiled in this  
6 office. This spreadsheet contained 1,121 names of individual and corporate entities.  
7 Subsequent reviews of the names contained in this spreadsheet obtained from returned  
8 waiver-of-service mail and reports from process server volunteers indicated that lists  
9 obtained from the above-mentioned sources either had not been purged of former water  
10 rights holders or were very out of date. The number of returned waivers of service by the  
11 post office plus the number of persons service was completed on, totaled over 150  
12 individuals or entities who no longer held valid water rights.  
13

14  
15 3. After reviewing additional information including a second data base provided  
16 by the Walker River Irrigation District and an affidavit dated February 27, 1996, authored  
17 by WRID attorney Dale Ferguson, the Mineral County list was formatted to reflect real  
18 water rights holders as of the date of the previous affidavit.

19  
20 4. I changed the layout of the spreadsheet from boxes to columns. From left to  
21 right, the first column lists the name(s) and address of each water right holder. The next  
22 column indicates Nevada or California water rights holders. The comment column lists  
23 some of the pertinent comments of the process servers, i.e. if the service was  
24 accomplished by waiver or whether the water rights holder is listed by a Post Office Box  
25 only. The last column on the right reflects the status of service. If the box has an "S", then  
26 service has been accomplished, if the box has an "UN", the water rights holder is not  
27 served because he cannot be located. There were several reasons that persons could not  
28

1 be located, i.e., moved with no forwarding address, had a Post office box for which the  
 2 Post Office will not release the physical address, deceased, etc. If the box is blank, we do  
 3 not know why the person cannot be served, i.e. attempted three times with no one at  
 4 home, did not respond to service. Husbands and wives at the same address and trusts with  
 5 multiple trustees were reduced by serving one of the adults at the same address, for  
 6 example, if the husband was served at the same address where the wife resides also, the  
 7 service was considered good as to the husband and the wife and the list was reduced by  
 8 two.  
 9

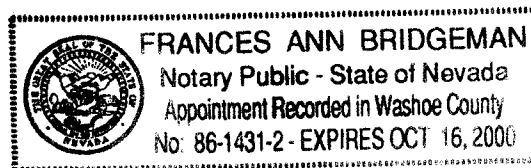

 11 5. At the instruction of the law firm of Zeh, Polaha, Spoo, Hearne & Picker,  
 12 attorneys for Mineral County, I personally served appurtenant water rights holders  
 13 where those rights are held in California. These water rights holders are incorporated into  
 14 the Appendix, the list of Walker River Water Rights Holders.  
 15


16 6. The total number of water rights holders listed in Appendix numbers 564. I  
 17 tallied the three categories with these results: Total served = 370, total not located = 131;  
 18 and total that could not be served are 11%.

MINUTE ORDER IN CHAMBERS

Proposed Intervenor Mineral County, Nevada moves (Doc. #88) for leave to serve by publication unidentified holders of water rights appurtenant to lands located within the Walker River system. This court by Order filed March 22, 1996 instructed the County to serve personally all holders of water rights on the Walker River system pursuant to Fed. R. Civ. P. 4. The County appealed that Order to the U.S. Court of Appeals for the Ninth Circuit; that appeal was dismissed (Doc. #89) for want of jurisdiction on the grounds that the order appealed from was neither a final appealable order under 28 U.S.C. § 1291, nor an appealable collateral order under the exception to Section 1291 described in Cohen v. Beneficial Loan Corp., 337 U.S. 541 (1949). United States v. Walker River Irrigation Dist., No. 96-15885 (9th Cir. Feb. 12, 1997) (mem.).

The Federal Rules of Civil Procedure permit service of process upon individuals, from whom waivers of service are not obtained under Fed. R. Civ. P. 4(d), "pursuant to the law of the state in which the district court is located, or in which service is effected, for the service of a summons upon the defendant in an action brought in the courts of general jurisdiction of the State . . . ." Fed. R. Civ. P. 4(e)(1). Mineral County proposes to serve unidentified water rights holders under the provision of the Nevada Rules of Civil Procedure permitting service by publication.

Those Rules provide, in relevant part,

In any action which relates to, or the subject of which is, real or personal property in this state in which such person defendant or corporation defendant has or claims a lien or interest, actual or contingent, therein, or in which the relief demanded consists wholly or in part of excluding such person or corporation from any interest therein, and the said defendant resides outside the state or has departed from the state, or cannot after due diligence be found within the state, or conceals [her]self to avoid the service of summons, the judge or justice may make an order that the service be made by publication of summons; said service by publication shall be made in the same manner as now provided in all cases of service by publication.

Nev. R. Civ. P. 4(e)(1)(ii) (Michie 1996).

The instant action is in the nature of a suit to quiet title to water rights; as such it is an action the subject of which is real property. By Order filed August 12, 1995, this court determined that all holders of water rights appurtenant to lands located within the Walker River system were necessary and proper parties to this action. Mineral County relies on the language in this rule permitting service by publication on defendants who "cannot after due diligence be found within the state."

Mineral County has compiled a list of the names and addresses of Walker River water rights holders from (1) the recorders' offices of the counties in Nevada through which the river flows, (2) the records of the Watermaster, (3) the records of the Nevada State Engineer, and (4) the records of Defendant Walker River Irrigation District. The County asserts that it has effected personal service upon all Walker River water rights holders which it has been able to identify. The County seeks leave to serve by publication pursuant to Nev. R. Civ. P. 4(e)(1)(ii) only those parties whose identity it has been unable to discover from any of the above-described sources.

The State of Nevada, the U.S. Board of Water Commissioners, and the Walker River Irrigation District, all resist Mineral County's Motion. They argue that Mineral County has not shown the requisite degree of due diligence sufficient to entitle it to serve any potential unidentified water rights holders by publication, as required by the express language of the rule. They argue that the County has not demonstrated to their satisfaction that these potential unidentified defendants reside outside of Nevada, have left the state, are concealing themselves to avoid service of process, or cannot be located through the exercise of due diligence. They seek to use to their advantage the fact that the County cannot identify these potential defendants. This argument reeks of the double bind. If the County knew these people's names, it would certainly be easier to locate them. It is precisely because their names are unavailable that the County seeks to notify all potential defendants of the instant action through summons by publication.

In an action to quiet title such as this one, a party plaintiff may acquire personal jurisdiction over unknown parties defendant on the basis of an affidavit stating "that the unknown defendants to be served by published notice of the pending suit were unknown and that their whereabouts could not be discovered after due inquiry and search has been made." Campbell v. Doherty, 206 P.2d 1145, 1150 (N.M. 1949) (internal quotation omitted). Prerequisite to service of summons by publication is a statement, by affidavit, of "the reasons why personal service cannot be made as well as the nature and extent of the investigation utilized to determine the whereabouts of potential defendants." Deer Park Lumber, Inc. v. Major, 559 A.2d 941, 943 (Pa. Super. Ct. 1989). Where, for example, a plaintiff in an action to quiet title to real property affirmed that he did not know the identity of the minor children of the deceased title owner, such affirmation was held sufficient to support service by publication on those children, where the published summons denominated them as the unknown heirs of the specified decedent. Archuleta v. Landers, 356 P.2d 443 (N.M. 1960). In the present action, given the attempts by the County to identify all the holders of water rights appurtenant to land located within the Walker River system, and given the County's forthright admission that the names of such holders which it has been able to acquire may not include all such holders, it seems not the least bit inappropriate to permit the County to notify as-yet-unidentified holders through summons by publication. Indeed, in its order dismissing the appeal in this case, the Court of Appeals has already favorably noted the possibility that the County could notify those as-yet-unidentified water rights holders in precisely the manner for which the County now seeks leave of this court.

The Due Process Clause of the Fifth Amendment to the Constitution of the United States constrains the exercise of judicial jurisdiction. A decree purporting directly and adversely to affect a person's legally protected interests -- such as the right to take or use water -- is void as in violation of the Due Process clause unless the party plaintiff employs a method of notifying such person of the pendency of the suit which is reasonably calculated to give them knowledge of the action at a meaningful time and in a meaningful manner. Personal service is not always required before a court adjudicates the legal rights of a natural person or of a corporation. If with due regard for the practicalities and peculiarities of the case, these conditions of notice are met, the Due Process Clause is satisfied. Mullane v. Central Hanover Trust Co., 339 U.S. 306, 314 (1950).

One issue remains for consideration. The Irrigation District, the State, and the Board of Water Commissioners point out, correctly, that because the Walker River flows across the California-Nevada border, a decree adjudicating water rights appurtenant to all lands situated within the Walker River system might naturally affect holders of water rights appurtenant to lands outside this State. Under the terms of Nev. R. Civ. P. 4(e)(1)(ii), service by publication in the present matter is proper only with respect to water rights appurtenant to Nevada lands, and not to lands in California. To the extent Mineral County seeks leave to serve by publication holders of water rights appurtenant to California real property, its request must therefore be denied.

For the foregoing reasons, IT IS THEREFORE ORDERED that the Motion (Doc. #88) filed by Proposed Intervenor Mineral County for leave to serve unidentified Defendants by Publication pursuant to Nev. R. Civ. P. 4(e)(1)(ii) is HEREBY GRANTED.

IT IS FURTHER HEREBY ORDERED that the Motion (Doc. #92) filed by Defendant Walker River Irrigation District to require Mineral County to identify and file a report concerning the status of service on each individual claimant to water rights appurtenant land located within the Walker River system is DENIED.

IT IS FURTHER HEREBY ORDERED that Proposed Intervenor Mineral County shall publish in the Miner County Independent News in Hawthorne, Nevada, the Record-Courier in Gardnerville, Nevada, the Mason Valley News in Yerington, Nevada, and the Review-Herald in Mammoth Lakes, Nevada, for a period of four (4) weeks, and at least once a week during said time, the following documents:

1. Summons to all holders of water rights appurtenant to lands located in the Nevada portion of the Walker River System who have not yet been served with process in this action;
2. Mineral County's Notice of Motion and Motion to Intervene (Doc. #2);
3. Mineral County's Proposed Petition in Intervention (Doc. #3);
4. Mineral County's Amended Complaint in Intervention (Doc. #20);
5. Mineral County's Amended Memorandum of Points and Authorities in Support of Mineral County's Amended Complaint in Intervention (Doc. #21); and
6. Mineral County's Motion for Preliminary Injunction (Doc. #22).
