1 **I. INTRODUCTION.**

2 By Minute Order dated April 14, 1998, the Court directed Mineral County to "file an
3 Affidavit regarding service and Motion for Publication." In an attempt to comply with this
4 order, Mineral County has filed a *Motion for Order of Publication* and points and authorities
5 in support thereof (the "Publication Motion"). Mineral County also filed an *Affidavit of Treva*
6 *J. Hearne* (the "Hearne Affidavit") to support its Publication Motion. As explained in detail
7 in Section III below, the Publication Motion and Hearne Affidavit do not comply with the
8 directions given by the Court at the April 14, 1998 status conference. They do not request
9 service on identified individuals and/or entities through publication and do not satisfy the
10 requirements for such publication.

11 After over three (3) years of motion after motion, hearing after hearing, representations
12 followed by contradictory representations, order after order, a frivolous appeal to the Ninth
13 Circuit Court of Appeals, further motions, hearings, representations and orders all concerning
14 Mineral County's misguided and uninformed attempts to comply with the Court's orders
15 concerning service in this matter, it is difficult to know where to begin and where to end with
16 respect to Mineral County's latest motion. Given the misinformation concerning whether
17 requiring personal service here is "historic" and "unique," it is perhaps best to begin with a
18 review of why service is necessary at all.¹

21 ¹In its recent points and authorities, Mineral County describes its proposed complaint as
22 a "water adjudication." It represents that it is the only party ever to have been required to
23 personally serve defendants in a water adjudication. Mineral County Points and Authorities at
24 5. First, this is not a water adjudication. The water adjudication ended in April, 1936. Mineral
25 County, as proposed plaintiff here, seeks to mount a collateral attack on that adjudication by
26 asserting a claim to water senior to and in derogation of all those previously adjudicated rights.
27 Second, it is simply not true that requiring personal service on defendants in federal court water
28 adjudications is unique. It is certainly not unique in collateral attacks on existing water decrees.
When the United States and the Pyramid Tribe sought more water for Pyramid Lake in a
collateral attack on the Orr Ditch Decree, over 17,000 individual defendants were named and
personally served. *See, United States v. Truckee-Carson Irrigation District*, 649 F.2d 1286, 1295
(9th Cir. 1981), *amended by* 666 F.2d 351 (1982) *aff'd in part, rev'd in part sub nom, Nevada v.*
United States, 463 U.S. 110, 103 S.Ct. 2906 (1983).

II. SERVICE IN ACCORDANCE WITH RULE 4 IS REQUIRED FOR A VALID JUDGMENT ON THE MERITS AND SO THAT INTERRELATED WATER RIGHTS ON THE WALKER RIVER SYSTEM CAN BE PROPERLY ADMINISTERED.

Personal jurisdiction is essential to a valid judgment on the merits. The permanent relief which Mineral County seeks is the first priority "right to, at least, 127,000 acre feet of flows annually reserved from the Walker River" for the benefit of Walker Lake. It seeks preliminary injunctive relief for twice that amount of water. If granted, that relief will adversely affect all claimants to the waters of the Walker River and its tributaries ("Walker River Claimants"). The Court cannot grant effective preliminary or permanent relief on the merits only with respect to Walker River Claimants who are properly served. If and when there is a decision on the request for preliminary relief or for permanent relief on the merits, it will be essential for the court to have jurisdiction to render a valid order or judgment which binds all water right claimants. On a river system, an order or judgment which did anything less would result in chaos.

For example, if Mineral County were completely successful, the water right established would be considered prior to an 1863 right of a properly served defendant. However, the judgment could not affect the 1876 right of a defendant who was not properly served. The river system could not be effectively administered where the 1876 right is junior to the 1863 right, but unaffected by the right established by Mineral County, which is senior to the 1863 right.

These facts are the reason that the Court required Mineral County to serve its intervention documents, pursuant to Fed. R. Civ. P., Rule 4, on all Walker River Claimants. *See*, Doc. No. 19 at 2. In fact, the Court has now ordered Mineral County to complete service in this matter on all Walker River Claimants pursuant to Rule 4 on no less than four different occasions. *See*, Doc. Nos. 19, 44, 48, 74.

The Court obviously recognized the need to have personal jurisdiction over all Walker River Claimants with respect to Mineral County's attempted intervention. The manner in which Mineral County has attempted to complete service of its intervention documents,

1 however, raises several questions as to whether the Court presently has or will ultimately
2 obtain the requisite jurisdiction.

3 **III. REPORT TO THE COURT CONCERNING THE STATUS OF SERVICE IN**
4 **COMPLIANCE WITH THE COURT'S ORDERS.**

5 **A. Introduction.**

6 Consistent with past practices, counsel for Mineral County continues to
7 misrepresent the information which the District has provided with respect to land owners
8 within the District. The Hearne Affidavit, which is not based upon personal knowledge and
9 is inaccurate in several respects, alleges that the District provided a 1988 and a 1992 list. *See*,
10 Hearne Affidavit at paras. 2 and 5. That is false. *See*, Affidavit of Madeline Sanford attached
11 hereto as Exhibit A. The records of the District are not, and were never intended to be, a
12 complete and current list of all Walker River Claimants. The District is organized under
13 N.R.S. Chapter 539. Its records of land ownership are used for purposes of assessment under
14 that Chapter. Irrigation district records and lists are not used for, and are not intended to be
15 used for, determining title to a water right. Title to a water right is transferred by deed.
16 Furthermore, until October 1, 1995, there was no requirement under Nevada law that an
17 irrigation district even be informed of a transfer of title to a water right. That changed under
18 the provisions of N.R.S. § 533.384(1)(b). Nevertheless, in the past, the District periodically
19 obtained deeds from the Lyon County, Nevada, Recorder for purposes of updating its records
20 for assessment purposes. That is an ongoing process and, thus, the District's records
21 continually evolve as it receives deeds and is able to incorporate the information in the deeds
22 into its records.

23 Counsel for Mineral County continues to allege that the District interfered with
24 Mineral County's ill-conceived attempts at service. Previously, Mineral County sought
25 substantial sanctions from the District. Doc. No. 31. The Court denied Mineral County's
26 requests for sanctions. Doc. No. 44. Although what the District did and why are not relevant
27 to the issues presently before the Court, they are explained in detail at Docket Nos. 39 and
28 40 and are supported by the Court's order denying Mineral County relief. Suffice it to say
that the District responded in good faith to inquiries and its response was based upon Mineral

1 County's unilateral decision to not mail documents which the Court's Service Order clearly
2 required be served.

3 Again, Mineral County has not provided the Court with factual information
4 which allows the Court to assess the status of service. Mineral County has provided
5 information which is not even internally consistent. In its points and authorities, Mineral
6 County represents that only 12 of 1,177 (or is it 1,107?) persons identified have not been
7 served. *See*, Mineral County Points and Authorities at 3-4. The Hearne Affidavit states that,
8 "Of the 307 persons and entities with post office boxes, 23 cannot be found or have not been
9 served." Hearne Affidavit at para. 11.

10 **B. The Requirements of Rule 4.**

11 **1. Service on Individuals.**

12 Rule 4(e) governs the manner in which individuals, other than infants
13 and incompetent persons, are to be served. In general, service on individuals may be
14 accomplished by delivering a copy to the individual personally, by leaving a copy at the
15 individual's dwelling house or usual place of abode with some person of suitable age and
16 discretion residing therein or by delivering copies to an agent authorized by appointment or
17 law to receive service. Fed.R.Civ.P. Rule 4(e)(2); *see also*, 4A, C. Wright and A. Miller, Fed.
18 Prac. and Proc. § 1094 at 67 (1987).

19 When service is made at a defendant's dwelling house or usual place of
20 abode, the return of service must show both that it was made at an appropriate place and that
21 the person with whom the process was left was of suitable age and discretion and resided
22 therein. *Id.* § 1096 at 72-73; 81. When service is made upon an agent, an actual appointment
23 for the specific purpose of receiving process is normally expected. *Id.* § 1097 at 84.

24 **2. Service on Infants and Incompetent Persons.**

25 Rule 4(g) governs service on infants or incompetent persons. In general,
26 such service must be accomplished as required for the service of similar process upon a
27 defendant in an action brought in state court. Fed.R.Civ.P. Rule 4(g); *Id.* § 1099 at 96-97.

28 *///*

1 **3. Service on Organizational Defendants.**

2 Under Rule 4(h), service on an organization may be made by leaving
3 copies with an officer, managing agent or general agent of the organization. It may also be
4 made by delivery to an agent authorized by appointment or by law to receive service of
5 process. *Id.* § 1101 at 101.

6 However, service under Rule 4(h) cannot be made by leaving a copy at
7 the officer's or agent's dwelling house or usual place of abode with a person residing therein.
8 Generally, it cannot be made by leaving it with someone at the officer's or agent's office. *Id.*
9 § 1101 at 103-104.

10 **4. Waiver of Service.**

11 Although there are only a few decisions under Rule 4(d), the plain
12 language of the Rule requires that a waiver of service form be executed by the defendant who
13 is waiving service, if that defendant is an individual. It also requires that if the defendant is
14 an organization, the waiver be executed by an officer, managing or general agent or other
15 agent authorized by appointment or law to receive service.

16 The provisions of Rule 4(d) do not apply to service on the United States,
17 its officers and agencies and foreign, state or local governments.

18 **C. Summary of the Status of Service on Identified Persons and Entities.**

19 Attached hereto as Exhibit B is a tabulation prepared by the District which
20 summarizes the status of service on persons and entities named in the caption (the "Service
21 Table"). The tabulation contains five (5) columns. The first column, entitled "Person or
22 Entity," sets forth the names of identified persons or entities named in the caption.

23 The second column, entitled "Type of Service," indicates the type of proof of
24 service for the identified person or entity on file with the Court. In this column, the letter
25 "W" refers to a filed Waiver of Service form. The letter "R" refers to a special Return of
26 Service form prepared by Mineral County and filed herein. The letter "S" refers to the return
27 on the backside of a standard Summons filed with the Court. The number after a letter is for
28 the District's use so that it may easily locate the particular service form in question. It is

1 internal to the District. If there is no entry in this column, it means the District does not have
 2 and could not locate in the Court file any proof of service with respect to the person or entity
 3 in question.²

4 The third column, entitled "Comments," includes information shown on the filed
 5 proof of service which bears on the issue of whether the process or method or manner of
 6 service was proper. This column also contains comments which address assertions made by
 7 Mineral County in the typed attachment to its Affidavit of Service.

8 The fourth column, entitled "Status of Service," is the District's best judgment
 9 on whether the identified person or entity has or hasn't been served.³ The letter "S" means
 10 served, the letter "NS" means not served and the letter "Q" means service is questionable.
 11 The District used the questionable ("Q") designation when in its judgment more information
 12 is necessary to determine if service is or is not complete.

13 The final column, entitled "Authority," includes information relevant to the legal
 14 basis upon which the District relied in reaching its judgment on the status of service.

15 Based upon its review, the District's conclusions are as follows. There are
 16 approximately 1,061 identified persons or entities named in the caption as set forth in the
 17 Service Table. Of those 1,061 identified persons or entities, the Service Table indicates that
 18 no service (NS) exists for approximately 240 of them because either there is no proof of
 19 service at all on file for those names, the proof of service is inadequate for those names or
 20 some other reason exists why service is not complete. Of those 1,061 identified persons or
 21 entities, the information on file shows that service is complete (S) on approximately 583 of
 22 them. Finally, service is questionable (Q) on approximately 190 of those 1,061 identified
 23 persons or entities. There are also approximately 48 instances where nothing was entered in

 25 ²The District's analysis includes a review of all filings through Docket No. 182, dated
 April 15, 1998.

 27 ³In making this determination, the District does not make any representation as to whether
 28 service has or has not "actually" been accomplished with respect to any individual or entity. The
 District has simply attempted to compile in a useable way the information filed with the Court
 in the form of Waiver of Service, Return of Service and Summons forms.

1 the "Status of Service" column because, for example, Mineral County asserted that the
2 individual or entity did not own a water right.

3 **D. Issues Related To The Status Of Proper Service.**

4 **1. The Return of Service Form Used by Mineral County Does Not**
5 **Contain the Necessary Information to Verify that the Requirements**
6 **of Rule 4 of the Fed.R.Civ.P. Have Been Satisfied.**

7 Mineral County has filed numerous return of service forms with the
8 Court to verify service upon individual Walker River Claimants. The vast majority of those
9 service forms are identical to the form attached hereto as Exhibit C.

10 The Return of Service Form contained in Exhibit C does not include
11 information which establishes that service on a person other than the proposed defendant was
12 at the proposed defendant's dwelling house or usual place of abode on a person of suitable age
13 and discretion residing therein. Thus, it cannot be determined if service is valid in cases
14 where service was effected on someone other than the proposed defendant and the service
15 form does not indicate the relationship between the individual accepting service and the
16 proposed defendant. The District has attached copies of a few Return of Service Forms hereto
17 as Exhibit D to provide examples of this problem for the Court's review.

18 **2. Mineral Failed to Identify the Proposed Defendant on Whom**
19 **Service was Attempted with Respect to the Notice in Lieu of**
20 **Summon Forms.**

21 The Court required Mineral County to serve a Notice in Lieu of
22 Summons with its intervention documents. The first two lines of the Notice in Lieu of
23 Summons contain blank lines for Mineral County to identify the proposed Defendant upon
24 whom service was attempted. Mineral County has failed to identify the proposed defendant
25 upon whom service was being made. Attached hereto as Exhibit E is an example of a Notice
26 in Lieu of Summons form wherein Mineral County failed to identify the individual or entity
27 upon whom service was attempted. This form was served on the undersigned counsel in his
28 capacity as resident agent for a Nevada corporation.

Mineral County's failure to identify the proposed defendant on the
Notice in Lieu of Summons causes substantial confusion with respect to those individuals who

1 may be capable of accepting service in more than one capacity. In other words, some
 2 individuals may be capable of accepting service on their own behalf, as trustee of a trust
 3 and/or as a designated agent capable of accepting service on behalf of a corporation or
 4 organization. Because Mineral County failed to identify the proposed defendant in some
 5 instances, when those particular individuals received a Notice in Lieu of Summons they would
 6 have had no idea if Mineral County was attempting to serve them personally, attempting to
 7 serve the trust or attempting to serve the corporation or organization on whose behalf they
 8 may be capable of accepting service. It also leaves spouses and cotenants unaware that
 9 Mineral County has attempted to serve all of them by serving just one of them.

10 **3. Contrary to its Continued Representations that Service is Complete,**
 11 **the District Believes that Mineral County Still Has Not Served**
 12 **Many of the Walker River Claimants.**

13 On several previous occasions, Mineral County has represented that it
 14 has completed service of its intervention documents as ordered by the Court. *See*, Doc. Nos.
 15 31, 63, 69, 75, 80, 88. These representations, however, have proven to be false. In fact, even
 16 though it represented that service was complete on several prior occasions, Mineral County
 17 now states that it has recently located persons "that had not been previously served" and
 18 expended funds "to accomplish the remainder of the personal service." Publication Motion
 19 at 3.

20 **(a) No Service Form Showing Valid Service.**

21 In some instances, there is simply no service form on file⁴ for
 22 the particular Walker River Claimant or the service form on file clearly establishes that service
 23 is not valid. Examples of a few of the Walker River Claimants and related service forms

24 ⁴The following names and page numbers from the Service Table provide a few examples
 25 wherein no service form is on file for the particular individual or entity:

26 Mattice, Lewis and Gayle (p. 35); Nesmith Family Trust Agreement (p. 39);
 27 Nugent, George D. and Evelyn (p. 40); Nuti, Ralph E. and Mary E. (p. 40); Nuti,
 28 Richard B. and Cynthia (p. 40); Sceirine, Joseph (p. 49); Shehady, Daniel Paul (p.
 51); Shoemaker Trust Agreement (p. 51).

1 which establish invalid service are attached hereto as Exhibit F.

2 (b) **Waiver of Service.**

3 The Waiver of Service Forms contain three blank lines for the
4 proposed defendant to record information as follows: 1) "Signature;" 2) "Printed name and
5 title, if any;" and 3) "Company or entity, if any." See, Exhibit G attached hereto. The District
6 concluded that service was complete for those Waiver of Service Forms wherein the signature
7 matched the printed name and the name was present in the Service Table. If the signature
8 did not match the name printed, the District concluded that service was incomplete or
9 questionable unless it could reasonably be concluded that the appropriate person had executed
10 the Waiver of Service Form. The District also concluded that service was incomplete or
11 questionable if the Waiver of Service form did not indicate that it was executed on behalf of
12 the organization listed in the caption.

13 (c) **Service on Cotenants.**

14 Another problem arises as a result of Mineral County's apparent
15 belief that service on one cotenant is the equivalent of service on all cotenants which own the
16 real property with appurtenant Walker River water rights. Mineral County must serve all
17 cotenants in order to effect proper service pursuant to Rule 4.

18 (d) **Service on Spouses.**

19 In some instances, Mineral County has served only one spouse
20 and not the other. Mineral County has counted that as service on both spouses. In this
21 regard, the District is not referring to those instances where Mineral County served, for
22 example, the wife with two copies of its intervention documents for both herself and her
23 husband. Rather, the District is referring to those situations where Mineral County has served
24 only one spouse and both husband and wife own an interest in the water right.

25 (e) **Service on Persons with Identical Surnames.**

26 In some instances where several individuals with the same last
27 name own an interest in water rights, Mineral County served only one of the individuals and
28 counted that service as effective on all individuals with that particular last name.

(f) **Service on Predecessor's-in-Interest.**

Finally, Mineral County asserts that service on a predecessor-in-interest to a current holder of Walker River water rights is sufficient. Rule 17 and Rule 25 are relevant to this issue. If, because Mineral County has not yet been allowed to file its amended complaint, its action is not yet commenced, Rule 17 requires it to name and serve subsequent owners. If, on the other hand, Mineral County's action is already commenced, under Rule 25(c), the successors-in-interest if they are to be named defendants must be served in accordance with Rule 4. *See*, Fed.R.Civ.P., Rule 25(c); Rule 25(a); 7C, C. Wright and A. Miller, Fed. Prac. and Proc. § 1958 at 516 (1986).

IV. THE PUBLICATION MOTION DOES NOT REQUEST, NOR MAKE THE FACTUAL SHOWING NECESSARY FOR THE COURT TO ORDER, THAT MINERAL COUNTY BE ALLOWED TO COMPLETE SERVICE THROUGH PUBLICATION ON IDENTIFIED INDIVIDUALS.

The Publication Motion requests that the Court enter an order allowing Mineral County to effect service through publication on "all unidentified parties." *See*, Publication Motion at 2. On April 1, 1997, the Court entered an order which stated the following:

For the foregoing reasons, **IT IS THEREFORE ORDERED** that the Motion (Doc. #88) filed by Proposed Intervenor Mineral County for leave to serve unidentified Defendants by Publication pursuant to Nev. R. Civ. P. 4(e)(1)(ii) is **HEREBY GRANTED.**

Doc. No. 99 at 4. In a subsequent order, the Court confirmed that it had granted Mineral County permission to effect service through publication "only with respect to unidentified and unserved potential defendants." Doc. No. 114 at 1.

The Court has already granted Mineral County permission to serve unidentified potential defendants through publication. The Publication Motion is unnecessary and redundant to the extent that it once again seeks the Court's approval to serve unidentified potential defendants through publication.

Assuming arguendo that the Publication Motion is construed to request permission to serve identified potential defendants through publication, the motion fails to make the necessary factual showing required by the relevant rules. Rule 4 of the Federal Rules of Civil

Procedure provides that if a waiver of service has not been obtained and filed, service on individuals, corporations and associations may be effected "pursuant to the law of the state in which the district court is located, or in which service is effected, for the service of a summons upon the defendant in an action brought in the courts of general jurisdiction of the State." F.R.C.P 4(e)(1) and (h)(1).

In Nevada,⁵ a court may order service by publication if the plaintiff establishes the following:

(i) General. When the person on whom service is to be made resides out of the state, or has departed from the state, or cannot, after due diligence, be found within the state, or conceals himself to avoid the service of summons, and the fact shall appear, by affidavit, to the satisfaction of the court or judge thereof, and it shall appear, either by affidavit or by a verified complaint on file, that a cause of action exists against the defendant in respect to whom the service is to be made, and that he is a necessary or proper party to the action, such court or judge may grant an order that the service be made by the publication of summons.

...

(ii) Property. In any action which relates to, or the subject of which is, real or personal property in this state in which such person defendant or corporation defendant has or claims a lien or interest, actual or contingent, therein, or in which the relief demanded consists wholly or in part of excluding such person or corporation from any interest therein, and the said defendant resides out of the state or has departed from the state, or cannot after due diligence be found within the state, or conceals himself to avoid the service of summons, the judge or justice may make an order that the service be made by the publication of summons; said service by publication shall be made in the same manner as now provided in all cases of service by publication.

⁵In its order dated April 1, 1997, the Court stated that "[t]o the extent Mineral County seeks leave to serve by publication holders of water rights appurtenant to California real property, its request must . . . be denied." See, Doc. No. 99 at 3.

1 N.R.C.P. 4(e)(1)(ii) (emphasis added).⁶

2 To begin with, Mineral County has failed to specifically name the Walker River
3 Claimants it has identified as candidates for service through publication and its efforts to effect
4 service on each. In light of this failure, it is impossible for Mineral County to make the
5 required showing under Nevada law to enable the Court to enter an order permitting service
6 by publication. Mineral County cannot possibly establish that a particular individual resides
7 outside of Nevada, has left Nevada, or cannot through due diligence be located within Nevada
8 unless and until it identifies that individual.

9 Even if Mineral County's failure to identify unserved Walker River Claimants is
10 overlooked, the Publication Motion and Hearne Affidavit clearly do not establish that certain
11 Walker River Claimants reside outside of Nevada, have left Nevada, or cannot after the
12 exercise of due diligence be found within Nevada, as required by Nevada law. Under Nevada
13 law there must be a showing of due diligence before service by publication is allowed. *Price*
14 *v. Dunn*, 787 P.2d 785, 787-88 (Nev. 1990). Mineral County has completely failed to make
15 this showing.⁷

16
17 ⁶It is not clear that Mineral County's proposed complaint seeks the type of relief
18 contemplated by the emphasized portion of the Nevada Rule. However, the standard of diligence
is similar under either the general rule or the emphasized portion.

19 ⁷It is extremely important for the Court to require Mineral County to make the factual
20 showing under N.R.C.P. 4(e)(1)(ii) before service through publication is allowed. In *Bomford*
21 *v. Socony Mobil Oil Co.*, 440 P.2d 713 (Okla. 1968), the Oklahoma Supreme Court stated the
following:

22 No rigid formula exists as to the kind of notice that must be given; the notice
23 required will necessarily vary with certain circumstances and conditions, and in
24 some instances, as in the case of missing or unknown persons, "personal notice
25 might not be reasonably possible." But notice by publication is clearly insufficient
26 with respect to one whose name and address are known or readily ascertainable
from sources at hand. In other words, the requirements of due process are not
satisfied unless due diligence has been exercised to find the whereabouts of the
defendant [citations omitted].

27 *Id.* (emphasis added). Therefore, in order to satisfy due process concerns and thereby vest the
28 Court with personal jurisdiction over proposed defendants served through publication, Mineral
County must make the factual showing required by N.R.C.P. 4(e)(1)(ii).

V. THE COURT HAS ALREADY ENTERED AN ORDER DESIGNATING THE DOCUMENTS WHICH MINERAL COUNTY MUST PUBLISH.

In the Publication Motion, Mineral County argues that it should be required to publish only the Notice in Lieu of Summons. The Court, however, has already designated the documents which Mineral County must publish. By order dated April 1, 1997, the Court directed Mineral County to publish the following documents in connection with its service upon unidentified individuals:

1. Summons to all holders of water rights appurtenant to lands located in the Nevada portion of the Walker River System who have not yet been served with process in this action;
2. Mineral County's Notice of Motion and Motion to Intervene (Doc. #2);
3. Mineral County's Proposed Petition in Intervention (Doc. #3);
4. Mineral County's Amended Complaint in Intervention (Doc. #20);
5. Mineral County's Amended Memorandum of Points and Authorities in Support of Mineral County's Amended Complaint in Intervention (Doc. #21)); and
6. Mineral County's Motion for Preliminary Injunction (Doc. #22).

Doc. No. 99 at 4. Based upon a stipulation to which Mineral County was a party, the Court later amended its April 1, 1997, order by requiring Mineral County to publish a Notice in Lieu of Summons instead of the summons (referred to in paragraph 1) and by relieving Mineral County of any obligation to publish Mineral County's Notice of Motion and Motion to Intervene (referred to in paragraph 2) and Mineral County's Proposed Petition in Intervention (referred to in paragraph 3). *See*, Doc. No. 122 at 2.

Thus, the Court has already ordered that Mineral County must publish, at a minimum, the following documents:

1. A Notice in Lieu of Summons
2. Mineral County's Amended Complaint in Intervention (Doc. No. #20);
3. Mineral County's Amended Memorandum of Points and Authorities in Support of Mineral County's Amended Complaint in Intervention (Doc. #21)); and

1 4. Mineral County's Motion for Preliminary Injunction (Doc. #22).

2 Finally, on more than one occasion, the Court has ordered Mineral County to distribute
3 a sample of the documents it intends to publish to the parties. To date, Mineral County has
4 failed to comply with the Court's orders in this regard.
