

INTRODUCTION

I.

After receiving the specific objections of the Walker River Irrigation District ("WRID") to the service of Mineral County, Mineral County reviewed the service affidavits once again. As a result Mineral County responds both specifically and by category to the objections of WRID. First is the summary of the service, then the arguments regarding the objections. Responses to more specific objections are on the attachment hereto. Mineral County notes that, although all the arguments must ultimately be resolved by the decision of the Court, some are specifically unaddressed by the law and Mineral County concedes that a decision must be made by the Court to resolve whether Mineral County's service is adequate. Those arguments made hereinafter in these Reply Points and Authorities are directed at the general categories of service objected to by WRID.

II.

SUMMARY OF SERVICE TO DATE

Sixty-one persons need to be dismissed because they are deceased, because they no longer have a water right and there is an objection to the service by WRID; and because of plain error in that some persons were listed as individuals when they were trustees to a trust and should be listed as trustee and not as an individual. A Motion to Dismiss is being filed this date with those names and an amended Caption reflecting those dismissals.

Thirty-one persons are on the publication list. These persons cannot be found and the affidavits filed by the Sheriffs or private process servers are attached thereto indicating the reasons that these persons were not found.

Ninety persons were served by substitution. An affidavit prepared by Mr. Jim Spoo which will be late filed because Mr. Spoo is unavoidably absent indicates that the volunteers were specifically cautioned not to serve anyone who was not an adult. Since most of the time the adult was a family member or a water rights holder also, the presumption of knowledge of the service is easily made. Mineral County submits that all service by substitution should be accepted without objection unless WRID knows of a specific reason why any individual service was defective. Without service by substitution the service accomplished would have been impossible requiring multiple trips back to the residences to find the specified party present. ¹

Twenty-six persons or entities were considered served by Mineral County and objected to by WRID in the instance where service on the prior owner had been made prior to the transfer of the water right. If the service was given an "S" by WRID in previous filings, Mineral County considered that service good as to that person, and therefore, good as to the subsequent owner. Service on the subsequent owner should be considered valid and no objection entertained.

WRID makes light of the work and effort employed by Mineral County and its references to the incredibly difficult task put before it to accomplish personal service. WRID references that personal service was made in the Truckee River adjudication and accomplished. Counsel for Mineral County spoke with a noted and long time water rights attorney in Reno who related that the Truckee River service was known as the "phone book" service. Members of the Pyramid Paiute Tribe drove around in trucks and heaved large bound documents into yards 30 years ago, checking off the addresses as they went. If Mineral County could have accomplished service in such a manner, the cost would have been a fraction of what has been expended by Mineral County. Moreover, the heightened scrutiny of this service and the interference by WRID and the Walker River Users Group was hardly experienced by the Tribe in the Truckee River experience.

Some services were objected to by WRID. Because of the loss of volunteers by decease or other reasons, rather than try to validate the affidavits, Mineral County has sent process out to be re-served on approximately 68 persons. These services, if they can be accomplished, will be, within the next two weeks and those affidavits filed with the Court.

Fourteen persons or entities have been placed with Sheriffs or private process servers and have not been returned for over four months. Mineral County believes that these persons will not be found and not served and should be further basis for publication. Mineral County has made every effort and will increase its efforts to get the affidavits of non-service back from the Sheriffs and private process servers prior to Court hearing in this manner.

III.

FURTHER REASON FOR PUBLICATION

The dismissal of deceased persons without finding their heirs or executors requires that publication take place. Once the list of water rights holders in the Walker River was determined and agreed to in front of Judge McQuaid and filed on October 10, 1997, the changes in ownership that occurred after that date are not reflected. Persons found to be deceased probably conveyed or demised the property to someone else. Mineral County has to have the list frozen in time at some point. Mineral County cannot possibly keep chasing a moving target. The most effective method of assuring that the unknown persons or entities who stand in the stead of these deceased persons is to publish the Notice in Lieu.

Individual affidavits indicating why persons cannot be found are attached hereto.

Those names are listed on the publication listed attached hereto. The affidavits indicate the due diligence that Mineral County exercised in trying to serve these individuals. Since many

of the individuals where service was attempted resided outside of the State, stating that the individuals have left the State is irrelevant. Mineral County made every attempt possible to locate and serve these persons as directed by the Court. We believe that these persons are not trying to intentionally conceal themselves in order to avoid service of process. These persons are in most instances extra co-tenants and simply have not informed anyone of their address or location. The co-tenant who resides or maintains the address has continued to maintain the water right by payment or use and there is no real need to identify the remaining co-tenants whereabouts so it has not been done.

The requirements of the statute simply do not apply in this instance where water rights holders are being sought and cannot be found. Mineral County has exercised due diligence in finding these persons as acknowledged by the United States Attorney on behalf of the Tribe. Mineral County will not swear a false affidavit in order to satisfy the language of the statute. The Court has the ultimate discretion to determine that Mineral County had exercised due diligence. In many instances when the service was referred to a Sheriff or Marshall and the service was taking longer than four months, a private process server was engaged to accomplish what the Sheriff or Marshall could not. If the private process server could not accomplish service, then Mineral County has asked for an affidavit. Mineral County has unsuccessfully made repeated requests for affidavits, especially with the Sheriff in Los Angeles County. The Sheriff neither sends the affidavit nor accomplishes service. This affects approximately 12-14 persons. Private process servers are re-serving approximately 68 persons and those will have return affidavits within the next two weeks as stated above in this reply.

PUBLICATION DOCUMENTS

IV.

Attached hereto is the estimated cost of publication of the Notice in Lieu from the Mason Valley News (Exhibit "1"). This is the approximate cost of the publication in the other newspapers. Mineral County has expended nearly \$150,000.00 in costs for this service. Mineral County has called upon each and every volunteer who desires to preserve the natural resource of Walker Lake and over 2,000 hours of volunteer time has been used in this service.

Mineral County calls upon the discretion of this Court to find that Mineral County has exercised due diligence and that is all that is required now prior to service by publication. Further, Mineral County calls upon the discretion of this Court to find that publication of the Notice in Lieu plus a notice that other documents will be available in convenient public places for review so that Mineral County can continue in this matter without the unduly burdensome cost of publishing all the intervention documents.

Mineral County has argued in previous briefs the standard of notice required must give notice that an action has been filed. The Notice in Lieu certainly gives persons the required notice that an action has been filed and by including the names of all persons in the caption, the specific notice required is met. The real property affected is the Walker River. The Court has adequately covered the reach of the Walker River in the newspapers chosen. It is noted that these are the newspapers usually used to give notice by the Watermaster of the Walker River.

The remaining issue is whether the Notice in Lieu published with a note that the

remainder of the documents will be available for review at the public libraries and courthouses in the area would be adequate notice. Mineral County prays the Court to make such a finding. Mineral County cannot expend another \$100,000.00 for service in this case and such a requirement means that Mineral County will be foreclosed from further attempts to have its case heard on the merits. WHEREFORE THE ABOVE-STATED REASONS, Mineral County, Nevada, respectfully requests that the Court make an order that Mineral County has completed personal service and that publication of the Notice in Lieu will commence immediately and

run for four consecutive weeks and that proof of publication must be filed with this Court.


