Chief Judge Robert C. Jones has reassigned the above-named cases to Magistrate Judge William Cobb for all further pretrial proceedings within his (Judge Cobb's) jurisdiction. Any party who may object to any content of the Joint Report shall file a separate Supplementary Report on or before January 30, 2012.
