1 1. At the August 22, 2012 Status Conference in this matter, the Court directed the
2 parties to this Stipulation to, among other things, collaborate with respect to preparation of a
3 list of threshold issues in subproceeding C-125-B upon which the parties agree, and to
4 separately identify those threshold issues upon which the parties cannot agree (Doc. 1746; Doc.
5 1749).

7 2. At the October 3, 2012 Status Conference in this matter, the Court directed that
8 such lists be submitted to the Court shortly before the next Status Conference, currently
9 scheduled for Monday, November 5, 2012 at 1:30 p.m.

11 3. Because of changes in the schedules of the attorneys for some of the parties to
12 this Stipulation, which changes were beyond their control, it has become impossible for the
13 undersigned counsel to meet in person, and it will be difficult for them to meet by telephone, to
14 discuss threshold issues and to comply with the Court's Order and direction prior to the
15 November 5, 2012 Status Conference.

16 4. At a meeting to take place on related matters on November 15, 2012 at South
17 Lake Tahoe, California, there will be an opportunity for the undersigned counsel, including
18 those from Colorado, New Mexico, California and Nevada, to meet in person to discuss
19 threshold issues in an effort to comply with the Court's Order and direction in subproceeding
20 C-125-B.

22 5. Based upon the foregoing, the undersigned counsel have requested in
23 subproceeding C-125-B that the time for compliance with the Court's August 22, 2012 Minute
24 Order and the Court's direction at the October 3, 2012 Status Conference concerning threshold
25 issues be extended to a Status Conference which will follow the November 5, 2012 Status
