The court inquires whether Mineral County is involved with the decision of threshold issues. Mr. Herskovits represents that because Mineral County is a party in the C-125-B proceedings, as well as the proposed intervenor in the C-125-C matter, Mineral County does participate in the discussions of threshold issues; however, Mineral County's position is different than that of the United States and the Tribe or the "upstream interests" (characterized as the defendants). The court appreciates the clarification and moves to addressing deadlines and setting the next status conference.

The court envisions that the parties submit an agreed upon list of threshold issues and submit one document to reflect such a list. The court acknowledges that the parties may not agree upon one comprehensive list; however, the court maintains its position that one document be filed. If there are separate threshold issues specific to an individual party and/or entity that list shall be reflected within the joint submission.

After discussion of possible dates and deadlines the court and parties agree upon the following:

- Telephonic conference set for Tuesday, November 27, 2012, at 9:00 a.m. for the limited purpose of discussing the submission of the threshold issues. Counsel shall dial 1-877-873-8017, enter access code 3416460, and enter the security code 112712, approximately five (5) minutes prior to the hearing.
- Deadline to submit the list of threshold issues is Thursday, December 6, 2012.
- Proposed Agenda due Thursday, December 6, 2012.
- Next status conference is set for Thursday, December 13, 2012, at 10:00 a.m. Counsel are encourage to attend this hearing in person; however counsel wishing to appear by telephone shall dial 1-877-873-8017, enter access code 3416460, and enter the security code 121312, approximately five (5) minutes prior to the hearing.
