**UNOPPOSED MOTION FOR
EXTENSION OF TIME TO
COMPLETE RULE 4 SERVICE
(First Request)**

1 Pursuant to Rule 6(b) of the Federal Rules of Civil Procedure and LR 6-1 and LR 6-2,
2 counsel for Mineral County moves the Court for an order extending the time for Mineral County
3 to complete Rule 4 service in subproceeding C-125-C from March 1, 2013 until March 11, 2013.

4 In support of this Motion, counsel for Mineral County represents the following to the Court:

- 5 1. Pursuant to the status conference held on August 2, 2012, and by the Court's
6 August 2, 2013, *Order Relating to Completion of Service*, the Court established a
7 March 1, 2013, deadline for completion of Rule 4 service in subproceeding C-
8 125-C. Doc No. 605.
- 9 2. Mineral County filed a service report on January 9, 2013, in which it requested
10 that the Court approve the completion of service efforts as to certain Proposed
11 Defendants, dismiss certain listed Proposed Defendants and substitute successors-
12 in-interest, and amend the names of certain Proposed Defendants in the caption.
- 13 3. On February 8, 2013, the Court granted the requests made in Mineral County's
14 January 9, 2013 service report. Doc. No. 665.
- 15 4. The Court's February 8, 2013, *Order Concerning Status of Remaining Proposed*
16 *Defendants to be Served Via Rule 4 Service* confirmed that there were four (4)
17 proposed defendants who remain to be served. Doc. No. 665.
- 18 5. Mineral County expects that Rule 4 service on these final four (4) Proposed
19 Defendants will be complete within the next few days and is in the process of
20 documenting final service efforts.
- 21 6. On Thursday, February 21, 2013, lead counsel for Mineral County, Simeon
22 Herskovits, was hospitalized and remains in the hospital.

1 7. Due to this hospitalization, documentation of final service efforts has been
2 delayed.

3 8. Mineral County expects to complete this documentation prior to the March 13,
4 2013, Status Conference.

5 9. The Primary Parties have been contacted and do not oppose this request.

6 NOW, THEREFORE, based upon the foregoing, Mineral County respectfully requests
7 that the Court grant this Unopposed Motion, and extend the time for Mineral County to complete
8 Rule 4 service to March 11, 2013.
