Centennial did purchase the ranch owned by the Strosnider family, of which Carolyn was the matriarch. Carolyn had already died when Centennial acquired the ranch, so technically Centennial succeeded to the interests of its sellers, who were (i) Strosnider, Inc., a Nevada corporation and (ii) James Sciarani, as successor trustee of the Strosnider Family Trust dated November 15, 1991, the Strosnider Survivor's Trust dated January 28, 1998, the Strosnider Exemption Trust, and the Strosnider Marital Trust and Strosnider Residual Trust.
