- 12 2. Appropriateness and timing of potential second amended complaint;
- 13 3. Completion of required Rule 4 service, service package, and a schedule for
14 completion of service;
- 15 4. Establishment of a deadline for responses to the Complaint (whether the Amended
16 Complaint in Intervention submitted March 10, 1995, or a possible second amended complaint to
17 be submitted by a date established by the Court);
- 18 5. Review of and possible need to update procedures in place for Rule 5 filing by and
19 service on represented and unrepresented parties, including changes which may have taken place
20 since May of 2015;
- 21 6. Discussion of potential additional case management requirements;
- 22 7. Such additional issues as may be identified subsequent to the filing of this agenda
23 and/or at the status conference;
- 24 8. Based on the discussion of Agenda Items 1 through 6, determination of the next
25 steps to be taken with respect to the remaining litigation;
