Mr. Herskovits concurs with the court's summary and states that the first order of business should be the completion of the Rule 4 service on the California riparian water rights holders. Mr. Herskovits suggests that the e-service order should also be done in this case after the Rule 4 service is completed and then, the second amended complaint should be filed.

The court and parties discuss the length of time needed for completing service of the remaining California riparian water rights holders. Mr. Herskovits and Ms. Thornton suggest several months for research to be completed and begin service in July with a completion date by the end of the year. Mr. Herskovits and Ms. Thornton states that funding for service of the remaining parties will have to be addressed by Mineral County in the next fiscal year, such that it is difficult to commence work on service until the County allocates funds to do so.

Mr. De Paoli states that there should be no delay in filing the second amended complaint and also suggests a multitasking approach by updating the service package and e-service order. Mr. Herskovits concurs with the multitasking approach.

The court and parties discuss the timeframe as to when the second amended complaint can be filed.

The court orders the second amended complaint to be filed by June 30, 2021.

After further discussion with the parties regarding the service packet and e-service order, the court orders the parties to work together drafting an e-service order to be submitted to the court by **June 2, 2021**.

The court orders a follow-up video status conference on June 16, 2021, at 10:00 a.m. The parties are directed to file a proposed agenda for the follow-up status conference on **June 14, 2021**.
