1 This matter is before the Court on Mineral County's *Motion to Allow Service by*
2 *Publication*. Upon consideration of the motion and for good cause shown, the Court enters the
3 following order to allow service by publication.

5 **1. Approval of the Proposed Notice**

6 In its motion, Mineral County presented the Court with a proposed *Notice by Publication*
7 *in Lieu of Summons* (Attachment A to the *Motion*). The Court approves the content of the
8 proposed *Notice*.
9

10 **2. Publications within which the Notice Shall Appear**

11 The content of the notice shall appear within the following newspaper publications: the
12 *Mammoth Times*, (Mammoth Lakes, California), the *Record Courier* (Gardnerville, Nevada); the
13 *Lyon County News Leader* (Lyon County, Nevada), and the *Mineral County Independent*
14 (Hawthorne, Nevada).

15 **3. Duration of Publication**

16 Mineral County shall complete publication of the notice by publishing the notice in each
17 newspaper identified above once a week for four (4) successive weeks with at least five (5) days
18 intervening between the respective publication dates not counting each publication day. Such
19 publication shall be completed within sixty (60) days of this *Order*.

21 **4. Notice of Completion**

22 Once the last notice has appeared in the newspapers identified above, Mineral County
23 shall file a proof of publication of the notice with this Court.
