





To Whom it May Concern,

We are named as defendants in this lawsuit as individuals. However, we get our water from the Virginia Lakes Mutual Water Corporation. The Virginia Lakes Mutual Water Corporation is also a defendant in this lawsuit. We believe this is an error, of sorts, to name us individually when we do not have *individual* water rights. In addition, we do not believe we are a creekfront property. We do not have a creek on our property nor do we have one adjacent to our property. The nearest creek is across two roads from our property line. While we are not experts, in our layman opinion, we would not consider our property "riparian". If that is the reason we are named in the suit as individuals, we ask that you please take a second look at the maps or come walk the property to see if a reconsideration of that designation is in order. It is our understanding that by completing these documents, we are acknowledging that we do not have individual or riparian water rights.
