1 3. In addition, on or about June 30, 1995, Mineral County
2 filed and served its Counter Motion for Sanctions; for Relief from

5 Points and Authorities in Support Thereof (collectively the
6 "Mineral County Sanction Motion").

7 4. On or about June 29, 1995, the Walker River Paiute Tribe
8 filed and served its Response to the District's Motion to Vacate
9 Schedule.

10 5. The District's Reply Points and Authorities in Support
11 of its Motion to Vacate Schedule with respect to the Tribe's
12 Response are due to be served on July 13, 1995 and with respect
13 to Mineral County's Response are due to be served on July 14,
14 1995.

15 6. Responses to the Mineral County Sanction Motion are due
16 to be served on July 18, 1995.

17 7. The District's Motion to Vacate Schedule and Mineral
18 County's Motion for Sanctions involve common factual and legal
19 issues.

20 8. The District intends to consolidate in a single document
21 its Reply Points and Authorities in Support of its Motion to
22 Vacate Schedule and its Points and Authorities in Opposition to
23 Mineral County's Motion for Sanctions.

24 9. In addition, the District requires additional time in
25 order to prepare its response to Mineral County's Sanction Motion.

26 10. There have been no previous extensions of time sought or
27 granted with respect to Reply Points and Authorities in Support of


