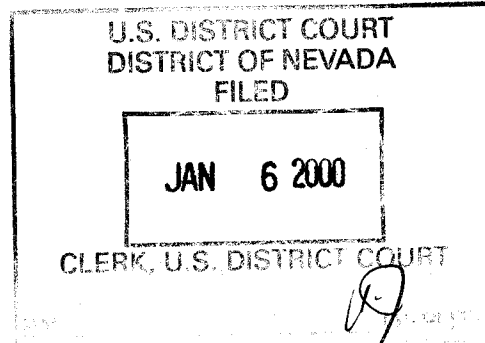

demonstrated that service by publication is warranted. IT IS ORDERED that counsel shall confer among themselves within the next 30 days and they shall submit to this Court a list that shows the following:

- 1) A list that reflects everyone who has been properly served.
- 2) A list of those people as to whom Walker River Irrigation District ("WRID") questions whether service is proper or has been made. WRID's objections or position with respect to why service is improper or has not been made shall be included.
- 3) A list of the people who Mineral County claims should be served by publication. Any objections or comments by any party about those specific people or entities shall be included.
- 4) A list of the people based on the information Mineral County has of the persons named in the caption who are no longer owners of real property with water rights, and the identification of who the current owners are.

Once the lists are put together, they are to be provided to the Court in a single pleading, to show what is in dispute and what is not in dispute for discussion at the next status conference.

IT IS ORDERED that a **Status Conference shall be held on Tuesday, February 8, 2000 at 11:00 a.m.** Counsel wishing to participate by phone shall contact the courtroom deputy, Rosemary Damron, at (775) 686-5835, at least two days prior to the hearing to advise her of the phone numbers where they may be reached for the conference.
