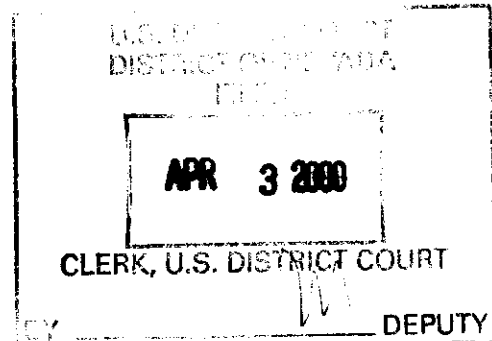


The Court approves and signs the proposed order and it is now the order.
