24 Mineral County respectfully submits this response in opposition to *Walker River*  
25 *Irrigation District’s Motion for Extension of Time*, Doc. No. 761, which requests the Court to  
26 extend the time for all parties to file replies in support of *Walker River Irrigation District’s*  
27 *Motion to Dismiss Pursuant to Fed. R. Civ. P. 12(b)(1)*, or in the Alternative, to Stay

1 *Proceedings with Respect to Mineral County's Amended Complaint in Intervention*, filed herein  
2 on March 31, 2014, Doc. No. 751, until a date which is 30 days after the United States of  
3 America files its response in opposition to the motions to dismiss filed in Subproceeding C-125-  
4 B. Mineral County opposes Walker River Irrigation District's motion for the following reasons.  
5 First, there has been no extension of any filing deadline for any party in 125-C. All briefing of  
6 all of the issues on WRID's motion in subproceeding C-125-C has been filed within the  
7 deadlines originally established by the Court. In addition, the issues in WRID's motion to  
8 dismiss are limited and straightforward. Thus, there is no justification for WRID's request for an  
9 extension of the deadline for filing their reply in subproceeding C-125-C. Accordingly, the  
10 Court should deny *Walker River Irrigation District's Motion for Extension of Time*.
