SPECIAL ORDER NO. 15

WHEREAS, it is deemed that suitable and practical provision is necessary for the conditional release of some week-end and holiday cited violators of Federal Regulations by personnel of the Bureau of Reclamation at Hoover Dam, near Boulder City, Nevada, whether the offenses cited be on the Nevada or Arizona sides of said Hoover Dam, on the posting of bail in the prescribed amount, rather than to hold in custody and detention any such certain cited offenders, Now, Therefore,

IT IS ORDERED that for all week-end and/or holiday violations and offenses of the Federal Regulations, expressly or otherwise warranting mandatory appearance, and/or arrest and physical custody and detention, the Bureau of Reclamation law enforcement personnel at said Hoover Dam, and the grounds and facilities thereof, in exercise of sound judgment and discretion may, in lieu of any such physical custody and detention of an alleged offender, alternatively conditionally release any such cited person on his posting of bail in the amount of TWO HUNDRED (\$200.00) DOLLARS, hereby fixed as reasonable and minimally-acceptable for such cited offenses and in such cases and circumstances; and

IT IS FURTHER ORDERED that for the purpose of accepting bail against proper receipt therefor in the aforesaid amount, and execution


IT IS FURTHER ORDERED AND DIRECTED that any such accept
