(IT IS COUNSEL'S RESPONSIBILITY TO ASSURE THAT THE FORMS AND CJA VOUCHER 21/31 ARE ACCURATE, COMPLETE AND CORRECT.)
- 4) Requests in excess of \$1600.00 must be approved by the Court of Appeals following the District Judges' approval.
- 5) All memoranda must include appropriate justification.
