RESPOND within three days of receiving this summons:

- Go to: www.nvd.uscourts.gov The **US District Court - District of Nevada** web site will have two pictures, one of each Nevada courthouse. Click on the eJuror bar below the pictures of the courthouses and follow the prompts. **DO NOT** use the BACK button on your browser. Use on the BACK button on the bottom of each web page.
- Free Internet access is provided at most county libraries.
- Provide an email address to receive reminders and early notification of cancellations.

CONFIRM your reporting STATUS after 5:00 pm on the day prior to your reporting date:

- Check online at www.nvd.uscourts.gov click on eJuror and **CURRENT STATUS**,
- OR call 702-464-5600 and selection option # 2 to check the Daily Reporting Message. You will need your Participant Number listed above.
- **If you live over 80 miles from the courthouse and require a travel day call the Jury Office at 702-464-5627 on the FRIDAY prior to your reporting date for reporting instructions.**
- If you appear and your date has been canceled or rescheduled you will not be paid.

GENERAL INFORMATION

- **Length of Service** - The average trial lasts less than five days. If you are not available to serve due to scheduling conflicts (vacation, medical appointments, business commitments, school, etc.) you may request a postponement **AS SOON AS POSSIBLE**.
- **Requests for Postponement or Hardship Excuse** must be made **at least one week PRIOR to your reporting date** by using one of the options below.

Request a **POSTPONEMENT** due to conflicting appointments, vacations, medical appointments, etc.

Request an **EXCUSE** if you have relocated outside the state of Nevada, your medical condition would not allow you to attend, etc. **DO NOT** attach a letter from your doctor unless specifically requested by this office. **DO NOT** assume your request for **HARDSHIP EXCUSE** has been granted until you receive notification from the Court. You must include your name, daytime phone number, participant and pool numbers and reason(s) for excuse. **If you are employed and requesting a medical excuse, you MUST explain why you can work but would not be able to attend jury service.**

- **ON-LINE** through eJuror at **www.nvd.uscourts.gov** (You must complete the on-line questionnaire prior to submitting a request.)
- **EMAIL** send your request to **jury_vegas@nvd.uscourts.gov** (you **MUST** include your PARTICIPANT number in the SUBJECT line)
- **FAX** 702-464-5611
- **MAIL** to the address on this summons OR
- **PHONE** 702-464-5627 (**ONLY Postponement requests** may be made by phone)

- **IN CONSIDERATION OF OTHERS, DO NOT WEAR SCENTED LOTIONS, PERFUMES, HAND CLEANERS, ETC.** If you do so you may not be allowed into the jury or courtroom and may be required to appear on another date.

DRESS APPROPRIATELY FOR COURT. SHORTS ARE NOT PERMITTED.

- **PARKING** is provided at the **Fremont Street Experience Parking Garage** located between Las Vegas Blvd. So, Carson Ave, 4th Street and Fremont Street. The entrance is located on 4th Street, which is a one way street running south to north. Bring your parking ticket to Court for Validation. **DO NOT park at a meter unless specifically directed by the Jury Office.**



- **U.S. DISTRICT COURTHOUSE, 333 Las Vegas Blvd South**, is located on the corner of Las Vegas Blvd South and Bridger St.

- **HANDICAP PARKING** and **SPECIAL NEEDS PARKING** is available. If you require special parking please contact the Jury Office at 702-464-5627.
